Pre-sales:

We have had a good quarter in terms of Pre Sales amounting to Rs. 214 crores (Registered sale of Rs. 68 crores and unregistered sale of Rs. 146 crores).

Operational Highlights for Q1FY25

- Area sold stood at **79,239 sq. ft.** a decrease of 21% QoQ.
- Sales value stood at **Rs. 214 crores**, a decrease of 10% QoQ.
- Collections stood at **Rs. 272 crores**, an increase of 8% QoQ.

Net Debt:

Net debt as at the end of Q1FY25 stood at **Rs.728 crores**, which is in line with our objective of reducing debt to a healthy level.

Receipt of Occupancy Certificate (OC)

In the Q1FY25, the Company received OC of Tower Atria of Marathon Nexzone project up to 26th Floors.
