- 1.  - 3. The management of the company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules relating to remote e-voting and e-voting during AGM conducted for the resolutions contained in the Notice of the 34th AGM of the members of the Company issued in compliance with Circular no. 09/2023 dated 25th September, 2023Circular no. 2/2022 dated May 5, 2022, Circular No. 21/2021 dated December 14, 2021, Circular No. 02/2021 dated January 13, 2021, Circular No. 20/2020 dated May 5, 2020, Circular No. 17/2020 dated April 13, 2020 and Circular No. 14/2020 dated April 8, 2020 and Circular No. 10/2022 dated December 28, 2022, and any other circular in this regard, issued by the Ministry of Corporate Affairs (MCA) and Circular dated Circulars dated May 12, 2020, January 15, 2021, May 13, 2022 and January 5, 2023, October 7, 2023, and any other applicable circulars issued by the Securities and Exchange Board of India (SEBI) if any, issued by the , permitted the holding of the Annual General Meeting ("AGM") through VC / OAVM, without the physical presence of the Members at a common venue.  - The members of the Company as on the "cut-off date i.e. Thursday, 29th August, 2024, were entitled to vote on the resolutions (item No. 01, 02 and 03 as set out in the notice of the 34th AGM of the Company).
 - iii. The votes cast via remote e-voting were blocked on Wednesday, September 04, 2024 immediately after completion of voting hours.
 - iv. The facility for e-voting at the AGM was provided at the 34th AGM on Thursday, the 05th day of September, 2024 for those members who attended the meeting but had not voted through the remote e-voting facility. Thereafter, the electronic votes cast through remote e-voting were unblocked at 12:17 pm, on 05th September, 2024 i.e. after counting the votes cast through e-voting at the AGM in the presence of 2 witnesses Mr. Dipenkumar Champakbhai Dhimmar who are not in the employment of the Company.
 - v. Then, the details containing, inter alia, list of Equity Shareholders, who voted through Remote e-voting and by e-voting at the AGM, "for" and/or "against" each of the resolutions that were put to vote, were generated from the e-Voting website of NSDL i.e. www.evoting.nsdl.com
 - vi. The Register to record the assent or dissent received has been maintained electronically. It contained the particulars of name, address, folio number or client ID of the shareholders, number of shares held by them, nominal value of such shares. There were no shares with differential voting rights in the Company; hence there is no requirement of maintaining the list of shares with differential voting rights.
