Pursuant to Regulation 30 read with Para A of Part A of Schedule III of the Listing Regulations and other applicable regulations, if any, it is hereby informed that National Stock Exchange of India Limited and BSE Limited has imposed fines of Rs.25,000/- each as per SEBI circular no. SEBI/HO/CFD/PoD2/CIR/P/2023/120 dated July 11, 2023 (Chapter-VII(A)-Penal Action for Non-Compliance) on Muthoot Finance Limited for violation of Regulation 44(5) of the SEBI Listing Regulations.

The Company is of the firm view that it is not in violation of Regulation 44(5) and is exploring legal remedies available against the imposition of fine by Stock Exchanges.
