

- The Shareholders of the company holding shares as on the "cut-off" date Monday, 23rd September, 2024, whose names were recorded in the Register of Members or in the Register of Beneficial Owners maintained by the Depositories were entitled to vote on the proposed resolutions as set out in item nos. I to 3 in the notice of the AGM of Sun Retail Limited dated Friday, 06th September, 2024.
- The notice of AGM along with Annual Report was mailed electronically to the members who had registered their emails with the depositories. Further, the company has provided the polling papers to the members who have attended the AGM of the company on Monday, 30th September, 2024 and has not availed the facility of remote e-voting.
- iii. The facility provided for Remote E-voting commenced from 09:00 A.M. on Friday, 27th September, 2024 and ended on 05:00 P.M. on Sunday, 29th September, 2024. The Remote E-voting facility was blocked
- iv. At the venue of the AGM the facility to cast the vote by poll was provided to facilitate those members present at the AGM and after the announcement made for the closing of the polling process by the chairman, Ballot Box kept for the polling were locked in my presence with due identification marks placed
- The Locked Ballot Box was subsequently opened in my presence and ballot papers were diligently
- vi. The voting done through Remote E-voting and Polling were reconciled with the record maintained by the Company/Registrar and Share Transfer Agent of the company and the authorization/proxies lodged with
