

An ISO 9001 Company Engineering Procurement, Construction & Commissioning ('EPCC') of a 300 Million Litre per Day (MLD) Mega Sea Water Reverse Osmosis ('SWRO') Desalination Plant in Yanbu, Kingdom of Saudi Arabia ('KSA').

The SWA, formerly known as the Saline Water Conversion Corporation (the 'SWCC'), is responsible for regulating and monitoring water sector business and services to enhance water sustainability and achieve the objectives of Saudi Arabia's Vision 2030. The SWA is currently managing over 40 desalination plants producing over 11 Million cubic meters per day and over 139 ground and surface water purification stations producing over 4 Million cubic meters per day.

This EPCC contract includes the scope of design, engineering, supply, construction and commissioning of the 300 MLD Mega Desalination Plant which will be developed on a greenfield site located in the west coast of the KSA, south of the Red Sea-facing city Yanbu al-Bahr and is scheduled to be completed within a 30month period. This Mega Desalination Plant will operate using Dual Media Filters followed by a two-pass Reverse Osmosis process and Re-mineralization to produce clean potable water, which will be further distributed by the SWA. This plant will be built with the state-of-the-art Desalination technologies, designed for superior energy efficiency and will produce stellar quality of water complying with the environmental regulations of the KSA.
