This is to inform that the Hon'ble Customs, Excise and Service Tax Appellate Tribunal, Eastern Zonal Bench, Kolkata ("**CESTAT Kolkata**") *vide* final order No. 76782/2024 dated September 03, 2024 (received by the Company on September 10, 2024) set aside the order bearing No. KOL/CUS/PORT/18/2015 passed by the Commissioner of Customs (Port) imposing an alleged amount of Rs. 52,42,872/- as deficient amount of customs duty along with an alleged fine and penalty of Rs.1,00,00,000/- each on account of such alleged short payment under Section 114A of the Customs Act, 1962. The CESTAT Kolkata pursuant to an appeal made by the Company in the year 2015 has disposed off in its entirety the demands of customs duty, fine and penalty imposed by the Commissioner of Customs (Port).

Pursuant to Para B of Part A of Schedule III of Regulation 30 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Circular SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023, we wish to inform you about the details of Final Order received by the Company as per Annexure-A.
