Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI circular dated 13th July, 2023, we are disclosing that Nomination and Remuneration Committee of UTI Asset Management Company Limited has approved; on 8th November, 2024 at 1446 hrs IST; the allotment of 21,252 equity shares of face value of ₹10 each pursuant to the exercise of options by eligible employees under ‘UTI AMC Employee Stock Option Scheme – 2007’.

Post the aforesaid allotment, the issued and paid-up share capital of the Company shall be increased from ₹ 1,27,52,25,500 (12,75,22,550 equity shares of face value of ₹10 each) to ₹ 1,27,54,38,020 (12,75,43,802 equity shares of face value of ₹10 each).

The new equity shares shall rank *pari-passu* in all respects with the existing equity shares.
