Sub: Clarification sought from KIOCL regarding News Appeared in Business Standard dated 28.10.2024 captioned 'NMDC-KIOCL merger on cards, awaits clearances from ministries, regulators'

This has reference to your e- mail dated October 28, 2024 seeking clarification on news item appearing in the Business Standard dated October 28, 2024 captioned 'NMDC-KIOCL merger on cards, awaits clearances from ministries, regulators'.

At the outset it is submitted that KIOCL Limited is a Mini-Ratna CPSE under the administrative control of Ministry of Steel, Govt. of India. Further, it is hereby clarified that the matter relating to NMDC-KIOCL merger falls within the purview of the Administrative Ministry i.e. Ministry of Steel, Government of India in consultation with Department of Investment and Public Assets Management (DIPAM), Ministry of Finance, Government of India.

It is to clarify that no negotiation took place so far. It is also clarified that company has not received any order from the Government of India on behalf of President for merger of NMDC limited and KIOCL Limited.

Therefore, it is submitted that the company does not have any price sensitive information/announcement to be shared with Stock Exchanges under regulation 30 of SEBI(LODR) Regulations, 2015. We request to take our clarification on record.
