**Sub:** Warning letter under SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('SEBI LODR').

Dear Sir/Madam.

This is in reference to the disclosure submitted by Adani Total Gas Limited ('the Company') on November 01, 2023, w.r.t "Audio link of Analyst/Institutional Investors Meet".

As per Regulation 30 read with sub-para 15(b) of Para A Part A of Schedule III of SEBI LODR, the listed entity shall inform the audio or video recordings and transcripts of post earnings/quarterly calls before the next trading day or within twenty-four hours from the conclusion of such calls, whichever is earlier.

Basis the above, it was observed that the disclosure for audio recording of the analysts / investors call pertaining to the Unaudited Financial Results (Standalone and Consolidated) of the Company for the quarter and half year ended September 30, 2023, held on Tuesday, October 31, 2023, which concluded at 5:30 p.m., was submitted on the next trading day i.e. on November 01, 2023, at 02:05 pm which was om the next trading day whereby the disclosure seems to have been submitted at a delayed as required under the aforesaid provisions.

The aforesaid non-compliance on your part is viewed seriously. You are hereby warned and advised to be careful in future, exercise due caution and initiate corrective steps to avoid recurrence of such lapses so as to ensure due compliance with the applicable provisions of SEBI LODR. Any aberration in future will be viewed seriously and appropriate action would be initiated.

The Company is required to disseminate a copy of the warning letter on the Stock Exchanges where they are listed. Additionally, the Company is advised to place before their Board of Directors the warning letter and the corrective measures taken by the Company to avoid such lapses.
