Ref: Company's earlier intimation dated May 27, 2023 vide letter no. SSFL/Stock Exchange/2023-24/035

Pursuant to Regulation 30 read with Regulation 31A of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and in continuation to our above referred letter wherein it was informed that Ms. Padmaja Gangireddy ('Outgoing Promoter'), vide her e-mail dated May 26, 2023 had inter-alia requested the Company to reclassify herself from Promoter category to Public category. However, such a request could not be processed at that time as her shareholding was above the prescribed threshold of 10%.

This is to inform that pursuant to reduction of shareholding, of the Outgoing Promoter along with person acting in concert, which today stands at 8.74%, the Company has received a fresh request on June 28, 2024 from the Outgoing Promoter for reclassification from Promoter category to Public category since the conditions relating to shareholding are now complied.
