resolutions as set out in item no. 1 in the Postal Ballot Notice dated Friday, May 29, 2024.

- ii. The postal ballot notice along with postal ballot form was mailed electronically to the members who had registered their emails with the depositories by NSDL.
- iii. The facility provided for Remote E-voting commenced from 09:00a.m. on Friday, May 31, 2024 and ended at 05:00p.m. on Saturday, June 29, 2024. The Remote E-voting facility was blocked thereafter. And physical postal ballot forms received, if any till 05:00p.m. on Saturday June 29, 2024 were considered for my scrutiny.
- iv. The postal ballot forms were kept under my safe custody before commencing the scrutiny of such Postal Ballot forms. After counting of the votes of physical Postal Ballot, the votes cast through Remote E-voting were unblocked by me in the presence of two witnesses who are not in the employment of the company. They have signed below in confirmation of the votes being unblocked in their presence. (No Physical ballot forms were received.)





- v. The voting done through Remote E-voting and Physical Postal Ballots were reconciled with the record maintained by the Company/Registrar and Share Transfer Agent of the company and the authorization/proxies lodged with the company.
