The said delay in procuring PIMS certificate was due to system issue in generating the relevant internal document.

(d)	details of the violation(s)/contravention(s) committed or alleged to be committed	DGFT Notification no. 11/2015-20, dated 25 th May 2022, amended the import policy for specific items mentioned in Annexure-A, falling under Chapter-48 of the Schedule-1 (Import Policy) from 'Free' to 'Free subject to compulsory registration under Paper Import Monitoring System (PIMS) with effect from 01.10.2022. Further as per the said notification the importer is required to submit registration not earlier than 75 th day and not later than 5 th day before the expected date of arrival of the import consignment. The goods imported by the Company under one of the Bill of Entry number 4414517 dated 9 th July 2024 falls under HS code mentioned in the Annexure-A of the said notification.
		However, the Company has obtained PIMS registration on 9 th July 2024 and the inward date for the shipment is 27 th June 2024. PIMS registration date is beyond the period as prescribed by DFGT. The delay of 13 days was due to difficulty in generating relevant document as the Company had recently migrated to a new ERP system. Due to the said delay, the goods imported under said Bill of Entry are liable to confiscation under section 111(d) and the Company being the importer is liable to pay penalty under section 112(a) of the Customs Act, 1962.
		In this regard, the Commissionerate passed Order in Original, dated July 29, 2024, F.No.: S/10-Adj-70/2024-25 Group II (H-K) and DIN. No.: 2024778NW0002782CD ordering to either confiscate goods imported vide BE No. 4414517 or provided an option to pay redemption fine of INR 70,000 under section 125 of Customs Act 1962 and penalty of INR 30,000 under section 112(a) of Customs Act 1962
