- entered into an escrow agreement with Kotak Mahindra Bank Limited ("Escrow Agent") on July 29, 2024 VIII. PROCEDURE FOR TENDERING THE EQUITY SHARES IN CASE OF NON-RECEIPT OF LETTER OF OFFER ("Escrow Agreement") and have opened an escrow account under the name and style of "Kothari Industria Corporation Limited OPEN OFFER ESCROW ACCOUNT" ("Escrow Account") with the Escrow Agent.
