Dear Stakeholders, Customers and Employees,





Revenue Composition

Our historical revenue composition shows a consistent pattern due to seasonal climate effects, where revenue in H1 tends to be lower than H2. For the financial year 2022-23, our revenue was Rs. 371 Cr, and for FY 2023-24, it increased significantly to Rs. 801 Cr. When analyzing our revenue composition year-on-year and H1 vs H2, it follows a ratio of 30% - 35% in H1 and 65% - 70% in H2.

For H1 FY 2024-25, we have closed total revenues at Rs. 483 Cr, and we expect H2 FY 2024-25 to be even stronger.






Closing Order Book

Closing Order book as of FY 2022-23 at Rs.




