## BLS International Completes Acquisition of 100% Stake in Citizenship Invest, a Global Leader in Citizenship and Residency Programs

**New Delhi, 4<sup>th</sup> October 2024:** BLS International Services Limited (“BLS”), a leading global tech-enabled service provider for governments and citizens, today announced the successful completion of its acquisition of 100% stake in Citizenship Invest (CI), a Dubai-based firm specializing in fast-track investor programs for residency and citizenship across more than 15 countries.

BLS, through its wholly owned subsidiary BLS International FZE, UAE, acquired CI for a total purchase consideration of USD 31 million (~INR 260 crore), fully funded through internal accruals. All necessary government and regulatory approvals were obtained ahead of schedule.
