We were appointed as statutory auditors of Yatra for Business Private Limited ("the Company") in 61th Annual General Meeting ("AGM") held on September 15, 2023 for a period of 4 years from the conclusion of the said meeting till the conclusion of AGM to be held in calendar year 2027.

Further to our various discussions, email from Manish Amin (Director) dated September 23, 2024, we note that the Company's Management wants to align the statutory auditor of the Company with the affiliates of the new group auditor after the statutory auditors of Yatra Online Limited (the Company's "Holding Company") have rotated out.
