**1. Revenue From Operations**

- The same store sales growth (SSSG) stood at +11% for the quarter (V-Mart at +12% and Unlimited at +8%)
- Income from LimeRoad digital marketplace of Rs. 12 Crore represents the commission income charged from sellers on the Net Merchandising Value (NMV) of Rs 29 Crore.

*The above revenue numbers are provisional and subject to review by the Statutory Auditors of the Company.*

**2. Store Opening & Closures**

- The Company has opened 7 new stores (5 under V-Mart and 2 under Unlimited) and closed 3 stores during the quarter.
- The 7 New stores include Two (2) stores in Bihar, One (1) store each in Gujarat, Tripura, Uttar Pradesh, Andhra Pradesh and Tamil Nadu.
- The 3 Closed stores include Two (2) stores in Karnataka and One (1) store in Telangana.
- With this the total number of stores now stands at 448 as at June 30, 2024 (V-Mart 370 and Unlimited 78).
