India hopes for its best ever tally in Paris Olympics, which opens today

or the time, India will have a 140strong support staff accompanying its athletes to the Olympics. From nutritionists, cooks and psychologists to sleep therapists, they will be led by Dinshaw Pardiwala, the chief medical officer, who will ensure the 117member contingent is fit and ready to perch itself on top of the podium.

The posse of doctors will also be embarking on an injury service surveillance programme and mental conditioning of athletes.

"Through our data-scouting team, we will be assessing how and why the injuries took place and whether it could have been prevented," Pardiwala explains. "We will also be monitoring the mental aspect to understand whether there should be any tweaks in our process.'



As the twoweek sporting extravaganza begins Friday. with a gala opening ceremony at the scenic Seine River, India will be looking to top previous

medal tally of seven at the 2020 Tokyo Olympics (held in 2021 because of the pandemic).

Can India's shooters hit bullseye? With 21 shooters, who earned quotas in air rifle, pistol, and shotgun events. India and China are the only two countries to earn all their Olympic

This time, the National Rifle Association of India decided to junk the practice of sending only quota winners to the Olympics. Instead, the athletes were picked based on competitive trials.

It will not be much of a surprise if one gets to witness multiple podium finishes for India at the state-of-the-art Chateauroux shooting range, which is a three-hour drive from Paris.

This will also be the first time that India will be sending more female shooters (11) than men (10) at the quad-It is a testament to India's consistent rennial multisport event, underscoring

the steady untick and the culmination of a century-long progression in women's participation in the Games.

It was Rajyavardhan Singh Rathore who brought home the first medal in shooting – a silver at the 2004 Athens Games. Since then, India has won four medals, including one gold, two silvers and one bronze.

The French capital secured the 2024 Olympics eight years ago, after numerous failed bids.

Apart from the main stadium where the athletics, and track and field events are scheduled, the rest of the events will take place across the city, with the opening ceremony to be staged on flotillas across the Seine.





Speaking to Business Standard, K Anand Kumar, managing director, IIL, a wholly-owned subsidiary of the National Dairy Development Board, said they had finished

"We will apply for approvals for the phase 2 clinical trials soon. We can expect vaccine to be commercially available in 2026-27 or so if things go according to plan," Kumar said.

Phase 1 clinical trials are done on a small group of people to determine the safety of the vaccine, while phase 2 and phase 3 trials are conduct-

successful and there have been no adverse reports. The company aims to start phase 2 and phase 3 trials soon.

Japanese pharmaceutical company Takeda has also initiated local clinical trials in the country. A Takeda India spokesperson told *Business* Standard they had received the no-objection certification (NoC) for clinical trials from Indian health authorities.

"We have received the NOC for clinical trials from health authorities and have initiated the clinical trial activity as per the local regulation in India and are committed to completing the trial at the earliest, followed by submission to Indian health

IIL's phase 1 trials have been authorities," the spokesperson said, adding they were currently engaging with the regulator for appropriate approvals and will launch vaccine after that in compliance with all regulatory requirements.

'We are currently working on the launch of vaccine in India after getting approval from regulatory authorities. As soon as we get clearance, we will launch the vaccine. We are committed to working with national authorities to find ways to support access to our vaccine when it is approved," the company said.

Takeda has developed Qdenga, a tetravalent vaccine for dengue. It is already available for children and adults in and environmental waste.

Takeda follows a dual pricing strategy in both private and public markets, and as such prices in the private market are higher in Europe than in Asian markets. WazirX finds no evidence of systems being compromised

Days after cryptocurrency platform WazirX reported a loss of \$230 million worth of digital assets in a massive security breach, the company's preliminary investigation found no evidence that its signer machines were compromised.

The affected multisig wallet at WazirX had six signatories: five managed by WazirX and one by Liminal custody, a platform that services the crypto exchange's wallets. A 'mutlisig' or multisignature wallet is a crypto wallet that requires two or more pri-this 'is the more likely cause of

In its blog published Thursday, the firm has clarified the nature of the attack and has shifted the blame to its wallet service provider Liminal.

While explaining the probable nature of the attack, WazirX said three of its signers received malicious transactions directly from Liminal due to a potential breach of the latter's infrastructure. WazirX said that based on
