Subject: **Clarification Regarding Discrepancy in Financial Results for 31.03.2024**

Dear Sir/Madam,

This is with reference to your mail dated 09.09.2024 regarding mismatch of Reporting Data of XBRL file while comparing with PDF filing for the year ending 31.03.2024. In this regard we would like to submit as under:

The Emmforce Autotech Limited, was previously operating as a partnership firm M/s Emmforce Inc before its conversion into a limited company w.e.f. 13.10.2023.

As per the requirement of regulation 33 of SEBI (LODR) Regulations 2015, the company submitted the Audited financial results (Standalone and consolidated) in pdf format for the half year and year ended 31.03.2024 on 30th May, 2024. The figures mentioned in the financial results submitted with BSE were pertaining for period from 13.10.2024 to 31.03.2024 i.e. the period from which the company got into existence after conversion of erstwhile partnership firm.

After the submission of the results on BSE portal, the management realized that the said figures were not reflecting to the true affairs of the business for the whole financial year but reflecting the affairs for a limited period i.e. 13.10.2023 to 31.03.2024. It was realized that in order to reflect the true state of affairs of the business for the whole financial year, the results of the company must contain the figures for the full financial year which includes the financial numbers of the erstwhile partnership firm i.e. M/s Emmforce Inc (from 01.04.2023 to 13.10.2023). Hence the company submitted the revised pdf of financial results on the same day. Also note that the XBRLs for the results were submitted taking into account the revised results only for both standalone and consolidated basis.

As per the revised results the Net profit for standalone results is Rs. 426.61 lakhs for the period 13.10.2024 to 31.03.2024 and Rs. 894.67 lacs for the period 01.04.2023 to 31.03.2024. The Net profit for consolidated results is Rs. 408.82 lacs for the period 13.10.2024 to 31.03.2024 and Rs. 876.88 lacs for the period 01.04.2023 to 31.03.2024.
