We wish to bring to your attention that Orient Tradelink Limited had initially notified on November 7, 2024, about the Board meeting scheduled for November 14, 2024 for considering following agenda items:-

- 1) To approve the Standalone Unaudited Financial Statements for the period ended September 30, 2024.

Subsequently, on November 14, 2024, the Company issued a further communication under Regulation 29(1), informing that the meeting would be rescheduled to November 20, 2024, for the approval of the financial results.

In accordance with the provisions of Regulation 33(3) of the SEBI (LODR) Regulations, 2015, the Company acknowledge the requirement to disclose the reasons for the delay in submitting the financial results by the due date. We would like to clarify that the delay in approval was not intentional. The Company had given a prior intimation as per Regulation 29(1) i.e two-working-day notice and accordingly rescheduled meeting held on November 20, 2024.

**This is due to the fact that the auditor required more time to complete their review and Issues related to the reconciliation of accounts and discrepancies in reporting results in delay for the submission for preparation of financial results for the quarter and half year ended 30<sup>th</sup> September, 2024.**
