NOTES TO AGM NOTICE FOR THE FINANCIAL YEAR 2023-24

1. As you are aware, in view of the situation arising due to COVID-19 global pandemic, the general meetings of the companies shall be conducted as per the guidelines issued by the Ministry of Corporate Affairs (MCA) vide circular No. 14/2020 dated April 08, 2020, Circular No. 17/2020 dated April 13, 2020, Circular No.20/2020 dated May 05, 2020 and General circular No.09/2023 dated 25th Sept., 2023, the forthcoming AGM/ EOGM will thus be held through video conferencing (VC) or other audio visual means (OAVM). Hence Members can attend and participate in the ensuing AGM/ EOGM through VC/ OAVM.
2. Pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015 (as amended), and MCA Circulars dated April 08, 2020, April 13, 2020 and May 05, 2020 the Company is providing facility of remote e-voting to its Members in respect of the business to be transacted at the AGM/EGM. For this purpose, the Company has entered into an agreement with Central Depository Services (India) Limited (CDSL) for facilitating voting through electronic means, as the authorized e-Voting's agency. The facility of casting votes by a member using remote e-voting as well as the e-voting system on the date of the EGM/AGM will be provided by CDSL.
3. The Members can join the EGM/AGM in the VC/OAVM mode 15 minutes before and after the scheduled time of the commencement of the Meeting by following the procedure mentioned in the Notice. The facility of participation at the EGM/AGM through VC/OAVM will be made available to at least 1000 members on first come first served basis. This will not include large Shareholders (Shareholders holding 2% or more shareholding), Promoters, Institutional Investors, Directors, Key Managerial Personnel, the Chairpersons of the Audit Committee, Nomination and Remuneration Committee and Stakeholders Relationship Committee, Auditors etc. who are allowed to attend the EGM/AGM without restriction on account of first come first served basis.
4. The attendance of the Members attending the AGM/EGM through VC/OAVM will be counted for the purpose of ascertaining the quorum under Section 103 of the Companies Act, 2013.
5. Pursuant to MCA Circular No. 14/2020 dated April 08, 2020, the facility to appoint proxy to attend and cast vote for the members is not available for this AGM/EGM. However, in pursuance of Section 112 and Section 113 of the Companies Act, 2013, representatives of the members such as the President of India or the Governor of a State or body corporate can attend the AGM/EGM through VC/OAVM and cast their votes through e-voting.
6. In line with the Ministry of Corporate Affairs (MCA) Circular No. 17/2020 dated April 13, 2020, the Notice calling the AGM/EGM has been uploaded on the website of the Company at www.noorussabahpalace.com the Notice can also be accessed from the websites of the Stock Exchanges i.e. BSE Limited and National Stock Exchange of India Limited at www.bseindia.com and www.nseindia.com respectively. The AGM/EGM Notice is also disseminated on the website of CDSL (agency for providing the Remote e-Voting facility and e-voting system during the AGM/EGM) i.e. www.evotingindia.com.
7. The AGM/EGM has been convened through VC/OAVM in compliance with applicable provisions of the Companies Act, 2013 read with MCA Circular No. 14/2020 dated April 8, 2020 and MCA Circular No. 17/2020 dated April 13, 2020 and MCA Circular No. 20/2020 dated May 05, 2020.
8. In continuation to this Ministry's **General Circular No. 20/2020** dated 05.05.2020, General Circular No. 02/2022 dated 05.05.2022 and General Circular No. 10/2022 dated 28.12.2022, circular No 09/2023 dated 25th Sept. 2023 and after due examination, it has been decided to allow companies whose AGMs are due in the Year 2023 or 2024, to conduct their AGMs through VC or OAVM on or before 30th September, 2024 in accordance with the requirements laid down in Para 3 and Para 4 of the General Circular No. 20/2020 dated 05.05.2020.
9. The Register of Members and share transfer books will remain closed from 24th day of September, 2024 to 30th day of September, 2024 (both the days inclusive)/
10. The Company has appointed Mrs. Neeta Desai, Practicing Company Secretary, Mumbai, holding CP No.4741 as scrutinizer to scrutinize the e_voting process in a fair and transparent manner.
11. M/s. Link Intime India Pvt Ltd. Operating from C-101, 247, LBS Marg, Vokhroli West, Mumbai, Maharashtra-400583 are the share transfer agent and Registrar of the Company and that, therefore, on need basis Mr. Anand Chawla and Mr. Ishwar

THE INTRUCTIONS OF SHAREHOLDERS FOR E-VOTING AND JOININGVIRTUAL MEETINGSARE AS UNDER:

Step 1 : Access through Depositories CDSL/ NSDL e-Voting system in case of individual shareholders holding shares in demat mode.

Step 2 : Access through CDSL e-Voting system in case of shareholders holding shares in physical mode and non-individual shareholders in demat mode.

- (i) The voting period begins on 27th day of September, 2024 at 9.30 AM and ends on 29th day of September 2024 at 5.30 PM. . During this period shareholders' of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date (**record date**) of **23rd day of Sept., 2024** may cast their vote electronically. The e-voting module shall be disabled by CDSL for voting thereafter.
- (ii) Shareholders who have already voted prior to the meeting date would not be entitled to vote at the meeting venue.
- (iii) Pursuant to SEBI Circular No. **SEBI/HO/CFD/CMD/CIR/P/2020/242 dated 09.12.2020**, under Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, listed entities are required to provide remote e-voting facility to its shareholders, in respect of all shareholders' resolutions. However, it has been observed that the participation by the public non-institutional shareholders/retail shareholders is at a negligible level.

Currently, there are multiple e-voting service providers (ESPs) providing e-voting facility to listed entities in India. This necessitates registration on various ESPs and maintenance of multiple user IDs and passwords by the shareholders.

In order to increase the efficiency of the voting process, pursuant to a public consultation, it has been decided to enable e-voting to **all the demat account holders, by way of a single login credential, through their demat accounts/ websites of Depositories/ Depository Participants**. Demat account holders would be able to cast their vote without having to register again with the ESPs, thereby, not only facilitating seamless authentication but also enhancing ease and convenience of participating in e-voting process.

Step 1 : Access through Depositories CDSL/ NSDL e-Voting system in case of individual shareholders holding shares in demat mode.

- (iv) In terms of **SEBI circular no. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated December 9, 2020** on e-Voting facility provided by Listed Companies, Individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. Shareholders are advised to update their mobile number and email Id in their demat accounts in order to access e-Voting facility.

- (xvi) There is also an optional provision to upload BR/ POA if any uploaded, which will be made available to scrutinizer for verification.

1. The procedure for attending meeting & voting on the day of the AGM/ EGM is same as the instructions mentioned above for e-voting.
2. The link for VC/OAVM to attend meeting will be available where the EVSN of Company will be displayed after successful login as per the instructions mentioned above for e-voting.
3. Shareholders who have voted through Remote e-Voting will be eligible to attend the meeting. However, they will not be eligible to vote at the AGM/EGM.
4. Shareholders are encouraged to join the Meeting through Laptops / IPads for better experience.
5. Further shareholders will be required to allow Camera and use Internet with a good speed to avoid any disturbance during the meeting.
6. Please note that Participants Connecting from Mobile Devices or Tablets or through Laptop connecting via Mobile Hotspot may experience Audio/Video loss due to Fluctuation in their respective network. It is therefore recommended to use Stable Wi-Fi or LAN Connection to mitigate any kind of aforesaid glitches.
7. Shareholders who would like to express their views/ask questions during the meeting may register themselves as a speaker by sending their request in advance atleast seven days prior to meeting mentioning their name, demat account number/folio number, email id, mobile number at (company email id). The shareholders who do not wish to speak during the AGM but have queries may send their queries in advance seven **days prior to meeting** mentioning their name, demat account number/folio number, email id, mobile number at (company email id). These queries will be replied to by the company suitably by email.
8. Those shareholders who have registered themselves as a speaker will only be allowed to express their views/ask questions during the meeting.

EXPLANTORY STATEMENT

Item No. 3.

Appointment of P Kaladharanm as Independent Non-Executive Directors of the Company a period of five consecutive years commencing from 01-10-2024

In term of Section 149 of the Companies Act, 2013 and to comply with the requirements of various committees the listed companies must have, the company must have atleast three non-executive independent Directors on its Board. The independent Directors shall hold the office as such for a period of 5 years and this tenure can be extended for further five years by passing a special resolution by the Company. An independent Director means a director other than the Managing and a whole-time director.

In term of the aforesaid provisions, Mr Ranjay K. Dawar was appointed as one of the Independent Non-Executive Directors of the Company in the 21st Annual General Meeting (AGM) of the Company held on 24th Dec 2014 for a period of five consecutive years commencing from 30th day of Sept 2014. In term of Section 149(11) of the Companies Act, 2013, no independent Director shall hold the office for more than two consecutive terms of five years each and his tenure expires on 30th Sept., 2024 and that therefore there is a need to induct an independent Director in his place so that the company is able to comply with the requirements of various committees .

To comply with the requirements relating to various Committees, the company must have at least three non-executive independent Directors on its Board. The Nomination and Remuneration Committee of the Company and in terms of the provisions of Sections 149, 150, 152 read with Schedule IV and any other applicable provisions of the Act and SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, has proposed to appoint Mr. P. Kaladharan as Non-executive Independent Director of the Company for his initial term of 5 years effective from 1st day of October, 2024.

The Company has received requisite declarations from Mr. P.Kaladharan that he/she meets the criteria of Independence as prescribed under sub-section (6) of Section 149 of the Companies Act, 2013 and Regulation 16(1)(b) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

In the opinion of the Board, Mr. P.Kaladharan fulfils the conditions specified under Section 149 (6) of the Act, the Companies (Appointment and Qualification of Directors) Rules, 2014 and Regulation 16(1)(b) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 for his appointments as Independent Non-Executive Director of the Company and are independent of the management. Copy of the draft letter for appointment of the aforesaid incumbents as Independent Non-Executive Directors setting out terms and conditions would be available for inspection without any fee by the members at the Registered Office of the Company during normal business hours (9:00 am to 5:00 pm) on any working day, except Sunday, up to and including the date of AGM of the Company.

The Board considers that appointment of Mr. P. Kaladharan as an Independent Non-Executive Directors would be of immense benefit to the Company and therefore it is desirable for the Company to continue to avail services of the entire aforesaid person as Independent Directors.

Accordingly, the Board recommends passing of the Special Resolution in relation for the appointment of Mr. P. Kaladharan as Independent Directors for the second term of five consecutive years effective from 1st day of October, 2024, for the approval by the shareholders of the Company.

Except Mr. P.Kaladharan being proposed appointees and their relatives, none of the other Directors and Key Managerial Personnel of the Company and their relatives is concerned or interested, financially or otherwise, in the resolution set out at Item No. 3 of the accompanying Notice of the AGM. MANAGEMENT DISCUSSIONS AND ANALYSIS

Company Approach to the Business

With a consistently growing middle class and increasing disposable income, the tourism and hospitality sector is expected to witness a healthy growth. The hospitality sector encompasses a wide variety of activities within the services sector and is a major direct and indirect job provider.

Due to expiry of the lease deed of company during the preceding , the company could earn on rental basis only Rs. 239.11 out of food and beverage services. However, the company is in the process of exploring new business opportunities for investment in land property for the development of a new hotel and banquet premises near airport, Bhopal, and considering this fact the financial results of the company for the financial year ended 31-03-2024 have been drawn on going concern basis.

Relying upon the view that the workforce is one of the key assets of hospitality industry, the Company is trying to retain most of the staff , although during the year under report , it laid off some 22 persons on their resignations. Regular meetings are held to improve communication and interaction between the employees,

Internal Control Systems:

As soon as the Company is able to establish a new hotel premises near the Bhopal Airport or at any suitable place it would ensure that it is able to obtain and maintain all statutory licensing with necessary controls, financial checks and ensure that the internal controls as regards operations are in line with industry norms. Proper accounting procedures would be adhered to ensure cost minimisation.

Opportunities

The Corporate and Conference segment along with foreign tourist segment is expected to show a decent growth. Economic projections appear to indicate towards a Major Boom for the Hospitality Industry. The Bhopal Airport is now an International Airport, and this is resulting in increase in number of flights.

Threats

The expiry of term of leasehold land of the company since July 2022 has been the major threat faced by the Company and it is considering a proposal to transfer its building structure and all immovable assets owned by it to the lessor for consideration to be decided mutually. Negotiation in this respect are still in process.

Risk and Concerns:

Since the Company is presently engaged in planning to set up a new hotel premises near the Airport in Bhopal or any other suitable place , at present it does not think worthwhile to analyse and foresee any potential risk.

Other Disclosures:

As soon as the company is able to get new opportunity to establish a hotel premises near the Air port Bhopal or at any other suitable place, it shall strive become a number one Hotel in the city. It shall work towards socio-economic growth, and in order to achieve this very goal shall focus on training the existing man power in accordance with the customer requirements and perceptions.

The extended lease term of leasehold land with respect to hotel segment of the Company had expired on July 7, .2022, building structure and assets affixed thereof (All immovable Assets) situated on the said land is owned by the Company and the company is under negotiation with the lessor to transfer the said building structure and assets affixed for a consideration. Since the negotiation is, still under process, no provision has been provided by the company for any deviation/ devaluation in the value of the said fixed assets and the loss is understood to that extent which is still to be ascertained.

Human Resources Development:

Led with the realization of the fact that continuous up-gradation of skills and service delivery systems /inputs go along with to make a decisive difference in the hotel industry , as amatter of policy and as soon the new hotel project is set up near the Bhopal Airport or any other suitable pladce, the company shall look into the up-gradation and the quality aspects of its human resources.

However the Company shall try to remain at par with industry standards, in the matter of employee's benefits and compensation and with establishment of the proposed new hotel premises and ensure that employees benefits and compensation package remains tailored to the industry norms enabling it to hire and retain skilled and professional manpower.

Industrial relations scenario in the company is expected to remain cordial with employess remaining committed to higher qualitative service and productivity. As soon the new hotel project is commissioned, the compnay management will try to play its role in maintaining and promoting harmonious relations.

REMUNERATION POLICY:

Based on the recommendations of the nomination and remuneration committee (NRC), the board has adopted a Remuneration policy for Directors, key managerial personnel and other Employees. The policy envisages payment of remuneration according to qualification, experience and performance.

The remuneration of the whole-time Director(s), is recommended by the Nomination and Remuneration Committee based on factors such as industry benchmarks, the Company's performance vis-à-vis the industry, performance/ track record of the. REPORT ON THE AUDIT OF THE FINANCIAL STATEMENTS

Opinion

We have audited the accompanying financial statements of **RELIABLE VENTURES INDIA LIMITED** ("the Company"), which comprise the balance sheet as at March 31, 2024, the Statement of Profit and Loss, including the statement of Other Comprehensive income, statement of cash flows, and the Statement of Changes in Equity for the year then ended for the year then ended, and notes to the financial statements, including a summary of significant accounting policies and other explanatory information.

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid financial statements give the information required by the Companies Act, 2013 ('Act') in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the state of affairs of the Company as at March 31, 2024, its Profit / Loss and cash flows for the year ended on that date.

Basis for opinion

We conducted our audit in accordance with the standards on auditing specified under section 143 (10) of the Companies Act, 2013. Our responsibilities under those Standards are further described in the auditor's responsibilities for the audit of the financial statements section of our report. We are independent of the Company in accordance with the code of ethics issued by the Institute of Chartered Accountants of India together with the ethical requirements that are relevant to our audit of the financial statements under the provisions of the Act and the rules thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the code of ethics.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Emphasis of Matter

We draw attention to Note 47 to the Financial Statements in which the Company has described that the terms of the existing lease and extended period of the hotel premises, wherein the key operative assets of the company are located, has expired as on July 07, 2022, the building structure and assets affixed thereon (All Immovable Assets) situated on the said lease land is owned by the company and the company is under negotiation with the lessor to transfer the said building structure and assets affixed for a consideration. Since the negotiation is still under process, we cannot comment upon the value of the said assets as reflected in the books as no provision has been provided by the company for any deviation/ devaluation in the value of the said assets, the loss is understated to that extent, which is still to be ascertained. Further, the company has shown Rental income earned by renting out its movable assets like vehicles and other Plant & Machinery used in hotel segment for which no supporting agreement/ documents has been provided to us for verification.

Key audit matters

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the financial statements of the current period. These matters were addressed in the context of our audit of the financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

We have determined the matters below to be key audit matters to be communicated in our report:

Key audit matters

Expected credit loss allowances- Recognition and measurement of impairment of financial assets involve significant management judgement. With the applicability of Ind AS 109, credit loss assessment is

How the matter was addressed in our Audit

We evaluated management's process and tested key controls around the determination of extent of requirement of expected credit loss allowances, including recovery process

now based on expected credit loss (ECL) model. The Company's impairment allowance is derived from estimates including the historical default and loss ratios. Management exercises judgement in determining the quantum of loss based on a range of factors. The most significant areas are loan staging criteria, calculation of probability of default / loss and consideration of probability weighted scenarios and forwardlooking macroeconomic factors. There is a large increase in the data inputs required by the ECL model. This increases the risk of completeness and accuracy of the data that has been used to create assumptions in the model. In some cases, data is unavailable and reasonable alternatives have been applied to allow calculations to be performed.

As per management opinion, there is no expected credit loss in several financial assets including the trade receivables of the Company and all are on fair value, based on the assessment and judgement made by the board of the company.

Balances of Various Financial Assets and Liabilities: Refer Note No. 38 to the financial statements which describes that the Balance of Receivables and Payables, including borrowings taken, loans & advances given, payable to vendors, security deposits given, other advances given, other liabilities, investments, Stock in trade, CWIP and other assets additions, advances from customers, etc., bank statement and bank reconciliation, service agreement with customer, returns and submissions made with statutory authorities i.e., PF, ESIC, PT, TDS & GST department are subject to confirmation and consequent reconciliation and adjustments, if any. Hence, the effect thereof, on Profit/ Loss, Assets and Liabilities, if any, is not ascertainable.

Deferred Tax Assets- Recognition and measurement of deferred tax assets towards MAT Credit Entitlement. The Company has MAT Credit Entitlement in respect.

The recognition of MAT Credit Assets involves judgment regarding the likelihood of the reasonable certainty of realisation of these assets, in particular whether there will be taxable profits in future periods that support recognition of these assets.

Management records MAT Credit assets as per the provision of the income tax laws, in cases where it is reasonably certain based on the presumed profitability determined on the basis of management estimation

& controls implemented in the company for trade receivables and other financial assets. It was explained to us by the management that the control exists relating to the recovery of loans & advances and other assets and in the opinion of the board there is no requirement making expected credit loss allowance. We have also reviewed the management response and representation on recovery process initiated for sample receivables, and based on the same we have place reliance on these key controls for the purposes of our audit.

We evaluated the management procedure and tested key controls employed by the management to review over the reconciliation and recoverability of the long outstanding assets and payability of long outstanding liabilities. Based on the explanations and representations provided by the management, it was explained to us that the Board is carrying out a regular review of balances of all outstanding assets and liabilities, based on the formal/ informal agreements/ arrangements with the respective parties involved. As per their opinion, there will be no substantial impact on their reconciliation with their balance confirmations. Based on the same we have place reliance on these key controls for the purposes of our audit.

In view of the significance of the matter we applied the following audit procedures in this area, among others to obtain reasonable audit assurance:

- Through discussions with management, we understood the Company's process for recording MAT Credit assets;
- Performed study and inquired into the basis of the management estimations of the future revenue for the reasonable certainty of utilisation of the Carried Forward MAT Credit entitlements and therefore recognition of MAT Credit

that sufficient taxable income will be available to assets absorb the MAT Credit assets in future.

Information other than the financial statements and auditors' report thereon

The Company's board of directors is responsible for the preparation of the other information. The other information comprises the information included in the Board's Report including Annexures to Board's Report, Business Responsibility Report but does not include the financial statements and our auditor's report thereon.

Our opinion on the financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the standalone financial statements or our knowledge obtained during the course of our audit or otherwise appears to be materially misstated.

If, based on the work we have performed, we conclude that there is a material misstatement of this other information; we are required to report that fact. We have nothing to report in this regard.

Management's responsibility for the financial statements

The Company's board of directors are responsible for the matters stated in section 134 (5) of the Act with respect to the preparation of these financial statements that give a true and fair view of the financial position, financial performance and cash flows of the Company in accordance with the accounting principles generally accepted in India, including the Indian Accounting Standards specified under section 133 of the Act. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding of the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statement that give a true and fair view and are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Company or to cease operations, or has no realistic alternative but to do so.

The most significant are as are loan staging criteria, calculation of probability of default/ loss and consideration of probability-weighted scenarios and forward looking macro economic factors. The board acknowledges and understands that these factors, since there is a large increase in the data inputs required by the ECL model, which increases the risk of completeness and accuracy of the data that has been used to create assumptions in the model. Based on the internal management analysis, as per Board Opinion, there is no requirement of provision for expected credit loss in several financial assets including the loans and advances, Trade and other receivables of the Company and all are on fair value, based on the assessment and judgment made by the board of the company.
47. The extended lease term of leasehold land with respect to hotel has expired on July 7, 2022, the building structure and assets affixed thereon (All immovable Assets) situated on the said lease land is owned by the company and the company is under negotiation with the lessor to transfer the said building structure and assets affixed for a consideration. Since the negotiation is still under process during our limited review, we could not comment upon the value of the said assets as reflected in the books as no provision has been provided by the company for any deviation/ devaluation in the value of the said assets, the loss is understated to that extent, which is still to be ascertained. Further, the company has shown Rental income earned by renting out its movable assets like vehicles and other Plant & Machinery used in hotel segment for which no supporting agreement/ documents has been provided to us for verification.
48. The company has adopted Ind 116 "Leases", effective 1st April, 2019, using modified retrospective approach and there is no significant impact on the financial results.
49. The Company has carried out impairment test on its Fixed Assets as per the date of Balance Sheet and the management is of the opinion that there is no asset for which provision of impairment is required to be made as per applicable Indian Accounting Standard.
50. No forward exchange contracts are outstanding on the balance sheet date which is entered to hedge foreign exchange exposures of the company.
51. All property Plant and Equipment were physically verified by the management of the company in accordance with a planned program of verifying them once in three years, which is due for verification considering the momentary restrictions due to COVID-19 pandemic. As per the opinion of the Board, there will be no substantial impact on their reconciliation with their physical verification as on the reporting date.
52. In the opinion of the board, the current assets and advances are approximately of the value stated, if realized in ordinary course of business. The provision for depreciation and for all known liabilities is adequate and not in excess of the amount reasonably necessary.

53 .Revaluation/ Fir valuation of PPE/ intangible assets/Investment property. Since the company has not carried out any revaluation of Its Property,Plant and Equipment (including Right-of-Use of Assets) and intangible assets held by the company during the year, the requirement of reporting regarding any revaluation of the same is nor applicable to the company. The company also does not have any investment property during the current year as well as previous year.

54.Benami Property held under Prohibition of Benami Property Transaction Act 1988 and rules made thereunder.

The Company do not have anybenami property, where any proceeding has been initiated or pending against the company for holding any Benami property.

55. Wilful Defaulter

The Company is not declared as willful defaulter by any bank or financial institution or lender

56. Mis-utilisation of Banking Barrowing.

The company has not taken any borrowings from banks and financial institutions During the current year, except for the pre-existing vehicle loans
