On being called upon by a person who introduced himself as Sh Praduman Sharma, Assistant Director, Directorate of Enforcement, Mumbai Zonal Office-II, Ceejay House, Worli, Mumbai, we, the above named panchas presented ourselves near the office premises of M/s Bahubali Properties Ltd, M/s Mangalam India Ltd and M/s Niharika India Ltd at 10, Princep Street, 2<sup>nd</sup> Floor, Kolkata 700072 on 12.08.2024 at 06:00 a.m. The above said officer then introduced us to his accompanying officers as Shri Nithin Jakkula, Enforcement Officer and Shri Sahil Aggarwal, Assistant Enforcement Officer alongwith eight nos of CRPF personnel including two female staff.
