## ખેડૂતો, સ્ત્રીઓ, ઉપેક્ષિત સમુદાયો માટે બજેટમાં નિરાશા : માયાવતી

બહુજન સમાજ પાર્ટીના વડા માયાવતીએ મંગળવારે કેન્દ્રીય બજેટ ૨૦૨૪-૨૫ને દેશના ગરીબો, બેરોજગારો, ખેડૂતો, મહિલાઓ,

હાંસિયામાં ઘડેલાયેલા અને ઉપેક્ષિત બહુજન (સમુદાયો) માટે નિરાશાજનક ગણાવ્યું છે. માયાવતીએ એક્સ (ટિવટર) પર હિન્દીમાં એક પોસ્ટમાં જણાવ્યું હતું કે, સંસદમાં રજૂ કરવામાં આવેલું કેન્દ્રીય બજેટ એ જ જૂની પેટર્નને અનુસરે છે, જ્યાં મુદ્દીબર ધનિક અને શ્રીમંત લોકો સિવાય, તે દેશના ગરીબ, બેરોજગાર, ખેડૂતો, સ્ત્રીઓ, મજૂરો હાંસિયામાં ઘડેલાઈ ગયેલા અને ઉપેક્ષિત સમુદાયો માટે સારા દિવસોની ઓછી આશા આપે છે અને તેમના માટે વધુ નિરાશાથી ભરેલું છે. બસપાના વડાએ જણાવ્યું હતું કે, જ્યારે દેશ અત્યંત ગરીબી, બેરોજગારી, મોંઘવારી અને અપૂરતા વિકાસ સામે ઝઝૂમી રહી છે, ત્યારે કેન્દ્રની સરકારનો તેના ઉત્થાન માટે કામ કરવાનો કોઈ ઇરાદો નથી. આ નવી સરકારમાં ૧૨૫ કરોડથી વધુ વંચિત વર્ગોના ઉત્થાન માટે જરૂરી સુધારાવાદી નીતિઓ અને ઇરાદાઓ અને તેમના માટે પાયાની સુવિધાઓની જોગવાઈનો પણ અભાવ છે. શું બજેટમાં આવી જોગવાઈઓથી લોકોનું જીવન સુખી અને સમૃદ્ધ બનશે? એમ તેણીએ પોસ્ટમાં જણાવ્યું હતું. માયાવતીએ કહ્યું કે દેશનો વિકાસ અને તેના લોકોનું ઉત્થાન આંકડાની ભુલભુલામણી ન હોવી જોઈએ. તેના બદલે, તેણે દરેકને રોજગારની તકો, ખર્ચ માટે નાણાં / આવક જેવી મુળભૂત પ્રગતિ પ્રદાન કરવી જોઈએ જેથી તેમને તેમના

## કેન્દ્રે સોના-ચાંદી, મોબાઇલ ફોન પરની કસ્ટમ ડ્યૂટીને ઓછી કરી

કેન્દ્રના નાણાં પ્રધાન નિર્મલા સીતારામને મંગળવારે સોના અને ચાંદીમાં બેઝિક કસ્ટમ ડ્યૂટીમાં ઘટાડો કરીને ૬ ટકા અને પ્લેટિનમ પર ઘટાડીને ૬.૪ ટકા કરવાની દરખાસ્ત કરી છે. લોકસભામાં તેમના બજેટ પ્રવચનમાં, તેમણે મોબાઇલ ફોન્સ, મોબાઇલ ચાર્જર પરની કસ્ટમ ડ્યૂટી પણ ઘટાડીને ૧૫ ટકા કરવાની દરખાસ્ત કરી છે. મહત્વના ૨૫ ખનિજો પરની કસ્ટમ ડ્યૂટીને મુક્તિ આપવાની જાહેરાત થઈ છે.

નાણાં પ્રધાને ફેરોનિકલ, બ્લિસ્ટર કોપર પરની બેઝિક કસ્ટમ ડ્યૂટી દૂર કરવાની જાહેરાત કરી છે, જ્યારે ખાસ ટેલિકોમ સાધન પર દસ ટકા હતી તેને વધારીને ૧૫ ટકા કરવામાં આવી છે.

સીતારામને કેટલાક બ્રૂડ સ્ટોક્સ, શ્રીમ્સ અને ફિશ ફીડ પરની બેઝિક કસ્ટમ ડ્યૂટી ઘટાડીને પાંચ ટકા કરવાની દરખાસ્ત થઈ છે.

બીજી તરફ, તેમણે જણાવ્યું હતું કે સરકાર એમોનિયમ નાઇટ્રેટ પર કસ્ટમ ડ્યૂટી વધારીને ૧૦ ટકા અને નોન-બાયોડિગ્રેડેબલ પ્લાસ્ટિક્સ પરની કસ્ટમ ડ્યૂટી વધારીને ૨૫ ટકા કરશે. તેમણે એમ પણ કહ્યું કે ઇ-કોમર્સ હબ્સ પીપીપી (પબ્લિક પ્રાઇવેટ પાર્ટનરશિપ) મોડમાં સ્થાપવામાં આવશે, જે એમએસએમઇને તેઓની પ્રોડક્ટ્સ વેચવામાં મદદ કરશે. પરંપરાગત કારીગરો તેઓની પ્રોડક્ટ્સને આંતરરાષ્ટ્રીય બજારોમાં વેચી શકશે, તેમ તેમણે કહ્યું હતું.
