Details of amendment and impact thereof or reasons of termination and impact thereof	The Company has received a letter from the Government of Chhattisgarh (" CoG "), informing the Company about closure of the Project and termination of the MoA as they are exploring alternate options to meet the Project objectives. The Company has today i.e. August 10, 2024, sent a letter to the CoG accepting the termination of the MoA and agreed to initiate steps for refund of the Escrow Amount.
