Disclaimer of Opinion

We have audited the standalone Ind AS financial statements of Garbi Finvest Limited ("The Company"), (PAN: AAACG9335R), which comprise Balance Sheet as at 31st March 2024, , the Statement of Profit and Loss, Statement of Changes in Equity and Statement of Cash Flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies and other explanatory information (hereinafter referred to as "the financial statements")

We do not express an opinion on the accompanying financial statements of the entity. Because of the significance of the matters described in the basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

Basis for Disclaimer of Opinion

The Company has not followed the system of estimated credit loss (ECL) model as determined under IndAS 109 of the financial instruments. The company has failed to comply with the implementation of Internal Financial Control (IFC) as mandated by the Companies Act, 2013. Furthermore, the company has not provided the necessary control design documentation. Without this critical information, we are unable to conduct tests or form an opinion on the effectiveness of the management controls.

Emphasis Of Matters:

We draw attention to the Standalone Financial Statements, which fully describe that the Company has not recognized any impairment on financial assets to reflect the business impact and any uncertainties arising out of the same. Such estimates are based on current facts and circumstances and may not necessarily reflect future uncertainties.

Our opinion is modified in respect of this matter.

Key Audit Matters

These matters were addressed in the context of our audit of the Standalone Ind AS financial statements for the year ended March 31,2024. These matters were addressed in the context of our audit of the standalone Ind AS financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. We have determined the matters described below to be the key audit matters to be communicated in our report.

The company's operational and financial processes are dependent on IT systems due to large volume of transactions that are processed daily. We therefore identified IT systems and controls over financial reporting as a key audit matter for the Company. During the review we come across that the company has no proper infrastructure in terms of IT system in keeping the data.
2.	Impairment of Financial Assets held at amortized cost: Since the loans and advances form a major portion of the Company's assets, and due to the significance of the judgements used in classifying loans and advances into various stages as stipulated in Indian Accounting Standard (IND AS) 109 and the management estimation of the related impairment provisions this is considered to be a key audit matter. The Company's impairment allowance is derived from estimates including the historical default and loss ratios. Management exercises judgement in determining the quantum of loss based on a range of factors. The most significant areas are: - Segmentation of loan book - Determination of exposure at default - Loan staging criteria - Calculation of probability of default / Loss given default - Consideration of probability weighted scenarios and forward looking macroeconomic factors	We evaluated the impairment principles used by management is not in accordance with the requirements of Ind AS 109, based on the understanding given by the management. We tested review controls over measurement of impairment allowances and disclosures in financial statements but are not satisfactory.

This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding of the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate implementation and maintenance of accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statement that give a true and fair view and are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management and Board of Directors are responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Company or to cease operations, or has no realistic alternative but to do so. Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not a guarantee that an audit conducted in accordance with SAs will always detect a material misstatement when it exists. However, due to the issues outlined in the Basis for Disclaimer of Opinion section of our report, we were unable to obtain sufficient audit evidence to form a basis for an audit opinion on these financial statements. Misstatements, whether arising from fraud or error, are deemed material if, individually or


