Review Report To The Board of Directors of Websol Energy System Limited

- 1. We have reviewed the accompanying statement of unaudited financial results of Websol Energy System Limited ("the Company"), for the quarter ended 30th June, 2024 ("the statement'), being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended.
- 2. 4)	The company is in progress for expansion plan by way of commissioning a 600 MWP Mono PERC bifacial solar cell manufacturing facility and a 550 MWP module manufacturing facility. The commercial production of first phase of 600 MWP Mono PERC bifacial solar cell project was commenced in last quarter of 2024 and 550 MWP module line is in progress.
5)	The figures for the quarter ended 31st March, 2024 are the balancing figures between the audited figures in respect of the full financial year ended 31st March, 2024 and the unaudited published year to date figures upto 31st December, 2023 being the end of the third quarter of the respective financial year, which was subject to limited review.
