

- The statutory Auditor has carried out a 'Limited Review of the above financial results for 2. the (half year) six month ended on 30th September, 2024.
- The Company is operating in two segment mainly Textile and Renewable Energy 3. (Windmill and Roof top Solar), reporting as per Accounting Standard -17 (AS-17 Segment Reporting) issued by ICAI, the company has furnished segment wise Revenue Result and Capital employed as required as per annexed. The Company has only domestic operation hence no geographical segment is given.
- As per MCA Notification No: G.S.R. 111 (E) dated 16th February, 2015 Companies whose 4. shares are listed on SME exchange as referred to in Chapter XB of SEBI (Issue of Capital and Disclosure Requirements) Regulation, 2009 are exempted from Compulsory requirement of adoption of IND-AS. As the company is covered under exempted category, it has not adopted IND-AS for preparation of financial results.
- 5. Earning per shares is calculated on the weighted average of the share capital issued by the company. Half yearly EPS is not annualized.
- Figures of half year ended 31st March, 2024 are the balancing figure between Interim 6. audited figures of half year ended on 30th September, 2023 and audited figures for the year ended on 31st March, 2024, are balancing figure which were not subjected to a limited review by us, as required under the Listing Regulations.
- 7. Provision for Income Tax has been recognised in each interim (quarter) on the basis of new tax regime opted by the Company.
- Deferred Tax has been recognised in each interim (Quarter) based on estimate made by 8. the Company.
- Figures pertaining to previous years/ period have been regrouped/ reworked/ 9. rearranged, reclassified and restated wherever considered necessary, to make then comparable with those of current year/period


