#### REPORT OF SCRUTINIZER

On Remote E- Voting and Electronic Voting in respect of Resolutions proposed through
Postal Ballot

[Pursuant to Section 110 of the Companies Act, 2013 and Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014]

To, Mr. Deepesh Shah (Company Secretary & Compliance Officer) Jetking Infotrain Limited

- A. The Board of Directors of M/s. Jetking Infotrain Limited (hereinafter referred to as "the Company") has appointed Mr. Anand Mukherjee (Membership No. F11804), Partner of M/s. AVS & Associates, Company Secretaries as the Scrutinizer by way of resolution passed by Board of Directors of the Company in their meeting held on Tuesday, May 28, 2024, for the purpose of Scrutinizing Postal Ballot conducted pursuant to the provisions of Section 110 of the Companies Act, 2013 read with rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 and other applicable provisions, if any, of the Companies Act, 2013 (the "Act") read with the General Circular Nos. 14/2020 dated April 08, 2020, the General Circular No. 17/2020 dated April 13, 2020, the General Circular No. 22/2020 dated June 15, 2020, the General Circular No. 33/2020 dated September 28, 2020, General Circular No. 39/2020 dated December 31, 2020 General Circular No. 10/2021 dated June 23, 2021 and including General Circular No. 20/2021 dated December 08, 2021, General Circular No. 03/2022 dated May 05, 2022, General Circular No. 11/2022 dated December 28, 2022 and General Circular No. 09/2023 dated September 25,2023, issued by the Ministry of Corporate Affairs ("MCA Circulars"), and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") and any other applicable law, rules and regulations, only through the E-voting process in a fair and transparent manner for following Special Resolutions as mentioned in the Notice of Postal Ballot dated May 28, 2024.
- 1. Appointment of Mr. Guruprasad Shenai (DIN: 10594029) as an Independent Director of the Company;
- 2. Re-appointment of Mr. Suresh Bharwani (DIN: 00667104) as Chairman & Non-executive Director of the Company for the period of 3 (Three) Years;
- 3. Re-appointment of Mr. Nand Bharwani (DIN: 00618386) as Vice Chairman & Non-executive Director of the Company for the period of 3 (Three) Years;

- 4. Re-appointment of Mr. Siddarth Bharwani (DIN: 02020370) as Whole Time Director of the Company for the period of 3 (Three) Years;
- **B.** The Compliance with the relevant provisions of the Act and rules made thereunder read with MCA Circulars in relation to e-voting on the proposed resolutions mentioned in the Postal ballot notice dated May 28, 2024, is the responsibility of the Management. My responsibility as a scrutinizer is to ensure that the voting process in all modes are conducted in a fair and transparent manner and render scrutinizer report based on reports generated from the electronic voting system provided by Link Intime India Private Limited (**'Linkintime'**)
- C. The Company had appointed Linkintime to provide an e-voting facility to the shareholders for casting their votes on the proposed resolutions. After the time fixed for the closing of E-voting, voting was closed and votes cast were unblocked;
- **D.** The members of the Company holding shares as on the "Cut Off" date i.e. Friday, May 31, 2024 were entitled to vote the resolutions forming part of notice;
- **E.** The remote e-voting commenced from **Wednesday**, **June 05**, **2024** at 9:00 A.M. (IST) and ended on **Thursday**, **July 04**, **2024** at 5:00 P.M. (IST) (both days inclusive) and the CDSL e-voting portal was unblocked in presence of Mr. Nitin Khandelwal and Mr. Omkar Samant who are not in employment of the Company;
