1. Revenue from Operations

- The same store sales growth (SSSG) stood at +15% for the quarter (V-Mart at +16% and Unlimited at +11%)
- Income from LimeRoad digital marketplace of Rs. 10 Crore represents the commission income charged from sellers on the Net Merchandising Value (NMV) of Rs 28 Crore.

The above revenue numbers are provisional and subject to review by the Statutory Auditors of the Company.

2. Store Opening & Closures

- The Company has opened 21 new stores and closed 2 stores during the quarter.
- The 21 New stores include Four (4) stores in Uttar Pradesh, Two (2) Stores each in West Bengal, Delhi, Assam, Tripura, Karnataka, Andhra Pradesh & Odisha and one (1) store each in Uttarakhand, Telangana & Bihar.
- The 2 closed stores were in Madhya Pradesh.
- With this the total number of stores now stands at 467 as at September 30, 2024.
