

I have completed the scrutiny of remote e-voting of postal ballot (e-voting) and submit my report as under:

- The Company has on 08th May 2024 completed the dispatch of Notice to its members via email through CDSL along with the details of Login ID and password to its members whose email ID was registered with the Company or its RTA as on cut-off date i.e. 03rd May, 2024.
