PROCEEDINGS OF THE TWENTY-NINTH ANNUAL GENERAL MEETING OF THE COMPANY

The 29th Annual General Meeting ('AGM') of Dynacons Systems & Solutions Limited ('the Company') was held on Monday, September 30, 2024 at 3:00 p.m. (IST) through Video Conferencing ("VC")/ Other Audio-Visual Means ("OAVM"), without the physical presence of the Members at a common venue. The Company, while conducting the Meeting, adhered to the Circulars issued by the Ministry of Corporate Affairs ("MCA"), the Securities and Exchange Board of India ("SEBI").

In accordance with the Secretarial Standard on General Meetings ("SS-2") issued by the Institute of Company Secretaries of India ("ICSI") read with Guidance/Clarification dated April 15, 2020 issued by the ICSI, the proceedings of the AGM were deemed to be conducted at the Registered Office of the Company which was the deemed Venue of the AGM.

1. Mr. Shirish M. Anjaria, Chairman cum Managing Director of the Company chaired the proceedings of the AGM. Ms. Pooja Patwa, Company Secretary informed that, the AGM was conducted through VC / OAVM. This meeting has been convened and being conducted in accordance with the circulars issued by Ministry of Corporate Affairs and Securities and Exchange Board of India (SEBI).
2. Ms. Pooja Patwa, Company Secretary of the Company welcomed all the members and called the meeting in order as requisite quorum was present.
3. She informed that the Register of Directors and Key Managerial Personnel and their Shareholding, Register of Contracts or Arrangements in which Directors are interested and certificate from Secretarial Auditors for Compliance of ESOP Scheme as per SEBI (Share Based Employee Benefits and Sweat Equity) Regulations, 2021, are available for inspection during the course of 29th AGM in electronic mode and members desiring to inspect these documents are requested to send email to the Company at the designated email address provided in the Notice of AGM.
4. She informed that the Company had tied up with National Securities Depositories Limited (NSDL) to provide facility for voting through remote e-voting, e-voting during the AGM and participation in the AGM through VC / OAVM facility. She also informed that the Company has provided live webcast facility for the Members to view the live proceedings of the AGM.
5. The Company Secretary informed the Members that pursuant to the provisions of the Companies Act, 2013, the Rules framed thereunder and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had extended the remote e-voting facility to the Members of the Company in respect of the resolutions to be passed at the Meeting. The remote e- voting commenced at 9:00 a.m. (IST) on Wednesday, 25th September, 2024 and ended at 5:00 p.m. (IST) on Sunday, 29th September, 2024 in proportion to their shares held as on cut-off date of September 23, 2024 on all the Ordinary and Special Resolutions as set out in the Notice of AGM. The Company Secretary informed the Members that the facility for voting through e-voting system was made available during the Meeting for Members who had not cast their vote prior to the Meeting.
6. The Company had appointed Mr. Hemant Shetye, Company Secretary (Mem No. F2827 and COP No. 2823) and Designated Partner of HSPN & Associates LLP, Practicing Company Secretary, as the Scrutinizer for the purpose of scrutinizing the process of remote e-voting held prior and e- voting during the AGM in a fair and transparent manner.
7. She further informed that the Company has received Authorized Representation for Trigem Infosolutions Limited for 20,86,475 Equity Shares constituting 16.44% of voting.
8. The Company Secretary then requested the Board of Directors to introduce themselves.
9. Ms. Pooja Patwa, Company Secretary of the Company, requested her team to start the presentation about the Company.
10. The Company Secretary then invited the Chairman to deliver his speech. The Chairman delivered his speech.

11. Thereafter, the Company Secretary invited Mr. Parag Dalal, followed by Mr. Dharmesh Anjaria, Executive Directors of the Company to address the shareholders.
12. Mr. Dharmesh Anjaria, Executive Director declared that the Notice convening the 29th AGM, Boards' Report and the Financial Statements along with Auditors' Report for the financial year ended March 31, 2024 had been sent through electronic mode to the Members. Accordingly, the Notice was taken as read. Mr. Dharmesh Anjaria then informed the members that the Statutory Auditor, M S P & Co., and the Secretarial Auditor, M/s. HSPN & Associates LLP, had expressed unqualified opinion in their respective audit report for the FY- 2023-2024, there were no qualifications, observations or adverse comments on the financial statements and matters which have any material bearing on the functioning of the Company. The Statutory auditors report on the standalone and consolidated financial statement respectively are available on page no. 89 and 146 of the Annual Report. The Secretarial Audit Report is enclosed as Annexure I of the Board's Report on page no. 51 of the Annual Report.
13. The Company Secretary invited the members who had registered themselves as speakers to address the meeting through VC/OAVM.
14. The following items of business, as per the Notice of AGM dated September 02, 2024, were put to vote through remote e-voting and e-voting at the AGM:

Mr. Dharmesh Anjaria thanked the Members present through VC and there being no other business to be transacted, the AGM was concluded at 03:33 p.m. Thereafter, the members who had not casted their vote through remote e-voting, were given opportunity to cast vote electronically for next 15 minutes' post which the e-voting lines were closed.

The meeting commenced at 3:00 p.m. and concluded at 3:33 p.m.
