अहमदाबाद, दि.३० : मुसळधार पाऊस आणि पुरानंतर आता गुजरातला असना चक्रीवादळाचा धोका निर्माण झाला. तब्बल ४८ वर्षांनी अरबी समुद्रात निर्माण झालेले हे चक्रीवादळ ओमानच्या किनाऱ्याकडे सरकण्याची शक्यता आहे. हवामान खात्याने सौराष्ट्र आणि कच्छमध्ये रेड अलर्ट जारी केलाय. याठिकाणी मुसळधार पावसाची शक्यता आहे.

हवामान तज्ज्ञांच्या म्हणण्यानुसार, सागरी भागात पावसासोबतच ताशी ७० किमी वेगाने वारे वाहत आहेत. पुढील ३ दिवस येथे मुसळधार पावसाची शक्यता आहे. चक्रीवादळाचा धोका लक्षात घेता या भागातील लोकांना सतर्कतेचा आणि सागरी क्षेत्रापासून दूर राहण्याचा सल्ला देण्यात आला आहे. तर दुसरीकडे, मच्छिमारांना पुढील काही दिवस समुद्रात न जाण्याचा सल्ला देण्यात आला आहे. सौराष्ट्र आणि कच्छवर निर्माण झालेले कमी दाबाचे क्षेत्र पश्चिम-दक्षिणपश्चिम कडे सरकण्याची

शक्यता आहे आणि कच्छ आणि लगतच्या पाकिस्तानी किनाऱ्याजवळील ईशान्य अरबी समुद्रात निर्माण होऊन शुक्रवारी चक्रीवादळात रुपांतर होण्याची शक्यता आहे. जेव्हा त्याचे चक्रीवादळात रुपांतर होईल तेव्हा त्याचे नाव मअसनाफ असेल. पाकिस्तानने हे नाव दिले आहे. अरबी समुद्रात १८९१ ते २०२३ या कालावधीत केवळ ३ चक्रीवादळे निर्माण झाली आहेत. १९७६ नंतर यंदाच्या ऑगस्ट महिन्यात अरबी समुद्रात निर्माण होणारे हे पहिलेच चक्रीवादळ असेल, असे हवामान खात्याने म्हटले आहे. यापूर्वी ओडिशात १९७६ मध्ये चक्रीवादळ निर्माण होणे ही दुर्मिळ गोष्ट असल्याचे एका हवामान तज्ज्ञाने सांगितले. दक्षिण गुजरात किनाऱ्याजवळ १९६४ मध्ये एक लहान चक्रीवादळ विकसित झाले आणि किनाऱ्याजवळ कमकुवत झाले. त्याचप्रमाणे, गेल्या १३२ वर्षात बंगालच्या उपसागरात ऑगस्ट महिन्यात

एकूण २८ वेळा अशी परिस्थिती निर्माण झाली आहे. हवामान विभागाने दिलेल्या माहितीनुसार यंदा गुजरातमध्ये सौराष्ट्र आणि कच्छ प्रदेशात या वर्षी १ जून ते २९ ऑगस्ट दरम्यान ७९९ मिमी पाऊस पडला आहे, तर याच कालावधीत सरासरी ४३०.६ मिमी पाऊस झाला होता. या काळात सरासरीपेक्षा ८६ टक्के जास्त पाऊस झाला. मध्य आणि लगतच्या उत्तर बंगालच्या उपसागरावरील आणखी एक कमी दाबाचे क्षेत्र पश्चिम-वायव्य दिशेने सरकण्याची शक्यता आहे आणि शुक्रवारपर्यंत पश्चिम-मध्य आणि लगतच्या वायव्य बंगालच्या उपसागरावर तीव्र दबाव निर्माण होण्याची शक्यता असल्याचे हवामान खात्याने सांगितले.

पोळा सणाच्या दिवशी बैलाना ओढा, नदीवर नेऊन आंधळ घालतात. त्यांच्या पाठीवर नक्षीकाम केलेली झूल, सर्वांगावर गेरूचे ठिपके, शिंगांना बेगड, डोक्याला बाशिंग, गळ्यात कवड्या व घुंगरांच्या माळा, नवी वेसण, नवा कासरा, पायात वाकरदोड्याचे तोंडे घालतात त्यानंतर पुणपोळी व सुरुची अन्नघात पोळा सणाचा शेतकऱ्यांमध्ये मोठा उत्साह असतो. आपल्या ऐपतीप्रमाणे शेतकरी बैलांचा साजशृंगार करतात. या सर्व पंहेत पूर्वीपासून सुरू आहेत. सध्या विज्ञानाने झपाट्याने प्रगती केली आहे शेतकरी शेती बैलाऐवजी यंत्राने करू लागले आहेत. त्यामुळे बैलांची संख्या कमी झाली आहे त्यांची जागा आता ट्रॅक्टरने घेतली आहे.
