In terms of Regulation 30 and other applicable provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (SEBI LODR) read with corresponding circulars and notifications issued thereunder, it is hereby informed that the Deputy Commissioner (ST) STU-2 (FAC), Begumpet Division, Hyderabad has issued an Order dated 5th August 2024 to the Company viz Havells India Limited.

The requisite details in terms of Regulation 30 and sub-para 20 of Para A of Part A of Schedule III of the SEBI LODR read with the SEBI Circular no. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 are furnished hereunder:

- (i) Name of the Authority – Deputy Commissioner (ST) STU-2 (FAC), Begumpet Division, Hyderabad
- (ii) Nature and details of the action(s) taken, initiated or order(s) passed – The Company has received an Order dated 05.08.2024 issued by the Deputy Commissioner (ST) STU-2 for the period starting from April 2019 to March 2020. As per this order demand of Rs. 28,942 has been raised related to tax of Rs. 8,942 and penalty of Rs. 20,000.
- (iii) Date of receipt of direction or order, including any ad-interim or interim orders, or any other communication from the authority – 5.08.2024
- (iv) Details of the violation(s)/contravention(s) committed or alleged to be committed – Demand has been raised on account of disallowance of Rs. 8,942 input tax credit claimed by Company for the period from April, 2019 to March, 2020.
- (v) Impact on financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible – The financial impact of the order is to the extent of the penalty levied. There is no material impact on financials, operations, or other activities of the Company.
