''भाजप–शिवसेनेच्या जाहिराती 'सामना'मध्ये कशा चालतात? जाहिरातींच्या माध्यमातून 'सामना'ची तिजोरी भरतात आणि सकाळी उठून पत्रकारांसमोर आव आणतात,'' अशी टीका भाजप नेते नितेश राणेंनी संजय राऊतांवर केली आहे. ''भाजप हा जाहिरातींवर चालणारा पक्ष आहे,'' असे वक्तव्य संजय राऊतांनी केले होते. यावर राणेंनी प्रत्यत्तर दिले.

नितेश राणे म्हणाले की, ''भाजप आणि शिंदेंच्या शिवसेनेच्या जाहिराती रोज सकाळी 'सामना'मध्ये कशा चालतात? एवढाच जाहिरातींवर आक्षेप असल्यास 'सामना'मध्ये त्या छापू नका. पण एकीकडे व्यवसाय करायचा आणि द्सरीकडे आमच्याच जाहिरातींवर टीका–टिप्पणी करायची. त्यांना भाजप आणि महायूतीचा पैसा चालतो, जाहिरातींच्या माध्यमातून 'सामना'ची तिजोरीभरणा चालतो आणि सकाळी उठून पत्रकारांसमोर आव आणतात. संजय राऊतांचा हा डबल-ढोलकीपणा महाराष्ट्रातील जनता चांगली ओळखून आहे.''

अदानींना विरोध म्हणजे देशाला-महाराष्ट्राला विरोध

नितेश राणे पूढे म्हणाले की, ''गौतम अदानींना ते एवढा विरोध करतात. परंतु, संजय राऊतांना आणि त्यांच्या मालकांना एवढेच गौतम अदानी खटकत असतील, तर तुम्हाला फिरण्यासाठी त्यांचे खासगी विमान कसे चालतें ? गेल्या दोन महिन्यांत अदानींना लपूनछपून कोणकोण भेटले, याची माहिती आम्ही द्यायची का? देशाच्या विकासात गौतम अदानींचे मोठे योगदान आहे. आज त्यांच्या माध्यमातून देशात मोठ्या प्रमाणात गुंतवणूक होऊन रोजगार निर्माण होत आहेत. त्यामुळे गौतम अदानींना विरोध म्हणजे देशाला आणि महाराष्ट्राला विरोध आहे. तरुणांना रोजगार मिळवून द्यायचे असल्यास गुंतवणूक करणाऱ्यांच्या नावाने खडी का फोडत आहात? तुम्हाला अंबानींना वेगळा आणि अदानींना वेगळा न्याय द्यायचा आहे. परंतु, त्याच अदानींचे खासगी विमान घेऊन उद्भव ठाकरे आणि कुटुंब सगळीकडे फिरतात, तेव्हा ते खटकत नाहीत. हा दुटप्पीपणा आणि नाटकीपणा जनता ओळखून आहे.''
