I hope this message finds you well. I am writing to formally resign from my position as Business Head of CC& Putty at HIL, effective October 1, 2024.

This decision has not come easily, but I must prioritize my health above all else. The past 15 days have been particularly challenging due to health issues, including sugar fluctuations, cervical problems, vertigo, and anxiety, which have led to signs of fatigue and burnout.

After careful consideration and discussions with my family, it has become clear that I need to take a sabbatical for immediate treatment, followed by Ayurvedic therapy to aid my recovery. Unfortunately, my current state does not allow me to handle work stress or travel.

I genuinely appreciate the opportunity to work alongside such talented leadership, and it saddens me to step away so soon. However, my health must take precedence.

I plan to begin my treatment on October 3 and will return to the city by October 15 & then follow it up with Ayurvedic treatment.
