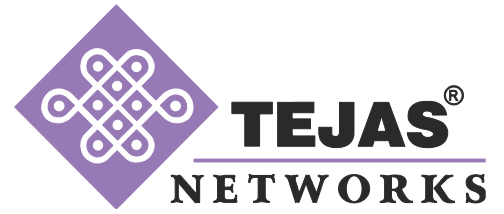

Re: Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform you that Saankhya Labs Private Limited (“Saankhya”), a majority-owned and controlled unlisted subsidiary of Tejas Networks Limited (the “Company”), has received an order from the Karnataka GST authorities (Order No: 108-2024-2025 / DCCTA -1.8/ GST/DRC-07/35/2024-2025, dated August 22, 2024, and received on August 29, 2024), which assesses a total demand of Rs. 9,58,959/- which includes Rs. 5,18,357/- for tax, Rs. 3,88,767/- for interest, and Rs. 51,835/- for penalty.

This demand pertains to a GST notice issued for the tax period from April 2019 to March 2020. Detailed information is provided in the Annexure.

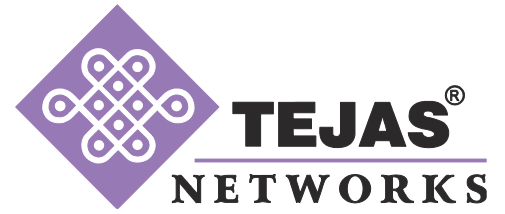
