With reference to the Outcome of Board Meeting dated 10.08.2024 vide which we have informed that the Board of Directors of the Company approved the proposal to invest upto 49.99% in Vraj Metaliks Private Limited.

Consequent upon the said acquisition of 4195750 equity shares of Vraj Metaliks Private Limited, the holding of Vraj Iron and Steel Limited has increased from 35.56% to 49.90% in the enhanced equity capital of Vraj Metaliks Private Limited with effect from 23<sup>rd</sup> September, 2024.


