



I, Neeraj Jain (Membership No. F-9599 & COP 26163), Proprietor of M/s Neeraj Jain & Associates, Practicing Company Secretaries, having my office at 1511, R.G. Trade Tower, Netaji Subhash Place, Pitampura, New Delhi-110034, was appointed as the scrutinizer by the Board of Directors of Omaxe Limited ("the Company") for the purpose of scrutinizing the process of remote e-voting/postal ballot on the resolutions set out in the Postal Ballot Notice dated May 28, 2024 ("Postal Ballot Notice").

I hereby submit my Report as under that:

1. In terms of the provisions of Sections 108, 110 and other applicable provisions of the Companies Act, 2013 (including any amendment(s), statutory modification(s) and/ or re-enactment(s) thereof for the time being in force) read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014, as amended and in compliance with General Circulars No. 14/2020 dated April 8, 2020, 17/2020 dated April 13, 2020, 22/2020 dated June 15, 2020, 33/2020 dated September 28, 2020, 39/2020 dated December 31, 2020, 10/2021 dated June 23, 2021, 20/2021 dated December 08, 2021, 3/2022 dated May 05, 2022, 11/2022 dated December 28, 2022 and 09/2023 dated September 25, 2023, issued by the Ministry of Corporate Affairs for holding general meetings/ conducting postal ballot (hereinafter collectively



- referred to as 'MCA Circulars'), the Company had completed dispatch of Postal Ballot Notice on July 8, 2024, all its eligible members through permitted mode.
- The Postal Ballot Notice was sent to those members of the Company, who have registered their email addresses with the Company / depository participants and whose name appeared in the Register of Members of the Company on July 05, 2024 ('cut-off date').
- The remote e-voting facility for this Postal Ballot activity was provided by Link Intime India Pvt. Ltd. ("LIIPL"), the Registrar and Share Transfer Agent of the Company.
- Particulars related to remote e-voting communications received from the Members, if any, have been entered in a Register, separately maintained for the purpose.
- The remote e-voting period remained open from Tuesday, July 09, 2024 (9:00 A.M onwards) till Wednesday, August 07, 2024 (upto 5:00 P.M.).
- All e-voting communications received upto the close of working hours i.e. 5:00 P.M.
 on Wednesday, August 07, 2024 (the last date and time fixed by the Company for evoting) were considered for my scrutiny.
- 7. The e-voting module of LIIPL was disabled on Wednesday, August 07, 2024 at 5:00 P. M., immediately after completion of voting time period.
- 8. The votes cast through remote e-voting were unblocked on Wednesday, August 07, 2024, around 5:05 P.M. in the presence of two witnesses viz. Mr. Vikram Kumar Chourasia (PAN: BZQPC3785G) R/o D-2, 396A, Shiv Durga Vihar, Lakkarput, Faridabad, Haryana-121009 and Ms. Pallavi (PAN CODPC8816B) R/o B-458, First Floor, Nehru Ground, Neelam Chowk, Faridabad, Haryana-121001 (who are not in the employment of the Company). 
