




Orders on Hand (OOH) Situation






Order Intake Overview: Distribution of Domestic Business




Order intake YTD Sept'24 w/o Nuclear















Revenue Trend

Revenue from Operations (MINR)










Profit Trend

Solar Project Inauguration:

On September 3, we celebrated a significant milestone of successful virtual inauguration of our open access solar power project. The event, held at the IPD, and inaugurated by Dr. Stephan Bross (CTO KSB SE & Co), was a memorable occasion for our company.







This remarkable project boosts a capacity of 6.65 Megawatts Peak (MWp) and is set to generate approximately 10 million kilowatthours (kWh) of power annually. This output is equivalent to meeting nearly 50% of KSB India's current total power requirements of manufacturing plant and substantially reduces our carbon footprint.

As a result, we are advancing towards our goal of making KSB more greener effectively elevating our share of renewable energy to 71%.


