Balmer Lawrie & Co. Ltd. announces second quarter results

November 06, 2024, Kolkata - Balmer Lawrie & Co. Ltd., a Miniratna I PSE with diversified business portfolios, has announced the second quarter results ending 30 September 2024 as per the accounts adopted. The results were approved by the Board of Directors in its Meeting held at New Delhi on 05 November 2024.

The total income for the second quarter stood at Rs. 648.66 crores as compared to Rs. 643.62 crores in the previous quarter. The Profit Before Tax (PBT) for the quarter ending 30 September 2024 stood at Rs. 68.58 crores as against Rs. 57.84 crores for the previous quarter ending 30 June 2024. The Net Profit After Tax (PAT) during the quarter was Rs. 49.69 crores as compared to Rs. 46.78 crores in the previous quarter.

The total income, Profit Before Tax (PBT) & Net Profit After Tax (PAT) for the six months period ended 30 September 2024 stood at Rs. 1292.28 crores, Rs. 126.41 crores and Rs. 96.47 crores respectively whereas the numbers for the corresponding period of the previous year were Rs. 1197.33 crores, Rs. 133.86 crores and Rs. 100.74 crores respectively.
