In furtherance to our earlier intimations dated 16th December, 2024 and 19th December, 2024, with respect to the Issue which opened on 16th December, 2024 and closed on 19th December, 2024, we wish to inform you that the Fund Raising Committee of the Company at its meeting held today, i.e. 19th December, 2024, approved the issue and allotment of 47,70,537 Equity Shares, to eligible 54 QIBs at the issue price of ₹ 2,096.20 per Equity Share (including a premium of ₹ 2,094.20 per Equity Share, which includes a discount of ₹ 110.29 i.e., 5% of the floor price, as determined in terms of SEBI ICDR Regulations), aggregating to ₹ 1,000 crores (Rupees One Thousand Crores only), pursuant to the QIP.

Pursuant to the allotment of Equity Shares under the QIP, the paid-up equity share capital of the Company stands increased from ₹ 13,80,75,828 consisting of 6,90,37,914 Equity Shares to ₹ 14,76,16,902 consisting of 7,38,08,451 Equity Shares. The shareholding pattern of the Company before and after the Issue, will be submitted along with listing application in the format specified in Regulation 31 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.
