- I, CS Manoj Hurkat of M/s Manoj Hurkat & Associates, Practicing Company Secretaries, Ahmedabad, have been appointed as Scrutinizer by the Board of Directors of GHCL Textiles Limited ("Company") on 29<sup>th</sup> October, 2024 for the purpose of scrutinizing the Postal ballot process with E-voting facility and for ascertaining the requisite majority on the Postal Ballot with E-voting facility carried out as per the provisions of Sections 108 and 110 of the Companies Act, 2013 read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014, as contained in the Notice of the Postal Ballot dated 29<sup>th</sup> October, 2024 circulated by the Company to all the members of the Company.
- 2.   - c. It has also been intimated that the Company has published the public notice under Rule 22 (3) of the Companies (Management & Administration) Rules, 2014 by way of an advertisement published on 27<sup>th</sup> November, 2024 in "Business Line All Edition" (English Language), "The Economic Times Ahmedabad Edition" (English Language) and "Financial Express" (Gujarati Language).
