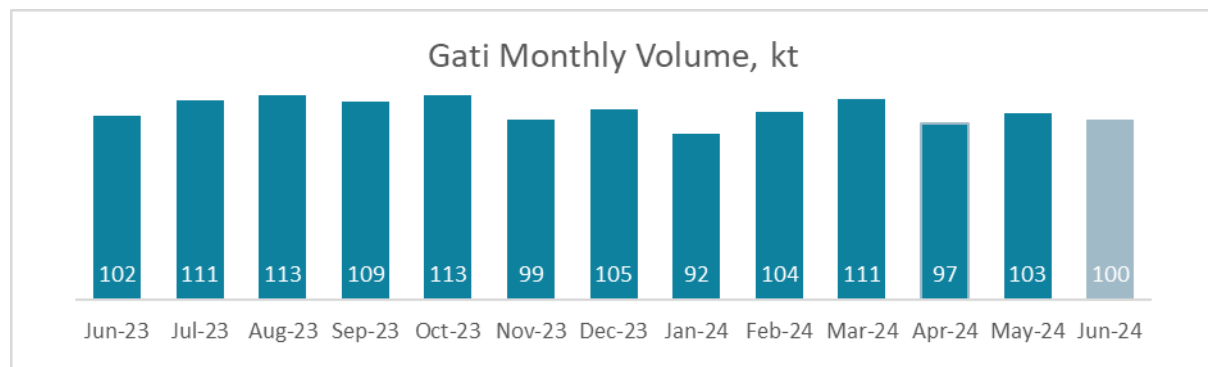

Subject: Monthly operational update

In accordance with SEBI (Listing Obligations and Disclosure Requirements) Regulation, 2015 and Code of Practices and Procedures for Fair Disclosure of Unpublished Price Sensitive Information in terms of Regulation 8 of SEBI (Prohibition of Insider Trading) Regulations, 2015, we are enclosing herewith a copy of key business parameters for the month ended June 2024.

Key highlights:

- Total volume, including surface and air express, stood at 100kt, recording a marginal decline of 3% as compared to May 2024 and 2% as compared to June 2023.
- The marginal decline in volume is in line with a de-growth registered by the express industry.
- During June 2024, the company has witnessed an improvement in yield of ~1% over last month on the back of better product mix.
