Such groups are designed to defraud the Stakeholders. This is to caution all the Stakeholders that neither Alankit limited or its Group Companies has authorized any person or its employees to undertake creation of the above-mentioned fake WhatsApp groups or other social media platforms. These Scammers are circulating bulk messages and creating WhatsApp groups using company's name.

Further, the messages received to the stakeholders read as follows:

**"Join the Alankit Limited stock group to get stock codes with a 30% weekly return"**

**"Dear Client, Your Trade Summary for led balars. Your Stock broker invites you to join the WS group: chat.whatsapp.com/Dx8EMAG4xg4K4YW1phzDob. NetRecPay Teamalankit."**

Alankit Group of Companies is in no way associated with the above fake group and shall not be held liable for any losses whatsoever suffered by any person who has relied or acted upon any information made available/recommendations made on the said fake WhatsApp group. As such these perpetrators are indulging in illegal and unauthorized activities, and we condemn this act of defrauding public. We caution the public to not fall prey to this fake group and stay vigilant of such scams.

Further, the Company's Managing Director have lodged the **Criminal Complaints against** these perpetrators **under Section 66D of the Information Technology Act, 2000 and Sections 316, 319(1), 319(2), 351(2)/(3) of the BNS** to Delhi Police, Crime Branch Cyber Cell.
