The amount is to be deposited by 06.09.2024. The said land is being alleged to be in Division's possession and thus we are being required to comply with Hon'ble SC's order passed in SLP filed by the petitioner who has share in this land.</p> <p>In the said case, due to non-deposit of amount by Lucknow Development Authority (LDA) and State Government, contempt proceedings have been initiated by the petitioner in which HAL is not a party.</p>
3	Date of receipt of direction or order, including any ad-interim or interim orders, or any other communication from the authority	Demand letter received on 05.09.2024
4	details of the violation(s)/contravention(s) committed or alleged to be committed	It has been alleged that the disputed unacquired land of plot no. 266 P, Ghazipur Saidulnisa, Lucknow (area 3-15-14-0 bigha) of the petitioner is in HAL's possession though the same has not been an acquired land. As such, HAL-ADL is liable to pay the compensation amount to the petitioner.
5	Impact on financial, operation or other activities of the Company, quantifiable in monetary terms to the extent possible	At present, the liability is of Rs.23,38,217/-, non-payment of which may result in issuing of recovery certificate by the district authorities thereby freezing of HAL Division's bank account(s). This amount may increase as the petitioner has been given the liberty to seek further enhancement of compensation, in accordance with the provisions of the 2013 Act

		which may come to the tune of Rs.16.5 crores, subject to final determination of the compensation amount by the district authorities.
6	Further course of action proposed to be taken by the Company	It has been decided by the Management to deposit the amount under protest to avoid any coercive action likely to be taken by the district authorities. Further, the Company is also exploring to take legal recourse in the matter.
