Based on the assessment of facts and prevailing law, the Company is of the view that the aforesaid order is arbitrary and unjustified. The Company shall file necessary appeal within stipulated time to the Authorities and the Company does not expect any material impact of the same on financial, operations or other activities of the Company.
