**Ref: Email of BSE dated 13.09.2024 related to imposing of fine of Rs. 11800/- on Company due to non-submission of voting results within the period provided under Regulation 44(3) SEBI (LODR) Regulations, 2015.**

**Sub: Application for withdrawal/waiver of fine along with disclosure under Regulation 30 of SEBI (LODR) Regulations, 2015.**

Dear Sir,

Please refer to your subject e-mail received by the Company on 13.09.2024 wherein you have informed about the non-compliance of the Company related to non-submission of voting results within the period provided under Regulation 44(3) SEBI (LODR), Regulation, 2015 and consequently imposing a fine of Rs.11800/- on the Company

In this regard, we would like to inform your goodself that the Postal Ballot viz. e-voting with regard to passing of Special Resolution related to approval for appointment of four new independent directors viz. Prof. (Dr.) Anup Kumar Ghosh, Shri Basavaraj Ningappa Bankapur, Dr. Sanjay Rangrao Chougule and Ms. Rita Amitabh Teaotia was carried out by the Company between July 25, 2024 and August 23, 2024 and the e-voting period ended on August 23, 2024 Company had two working days' time to file the voting results under the provisions of Regulation 44(3) so it could have filed voting results with the stock exchanges upto 26.08.2024. Despite such leeway available, Company immediately filed the voting results on 23.08.2024 at 8.46 p.m. in both XBRL and PDF mode. (Copy of acknowledgments attached as annexure A), wherein inadvertently Company had mentioned the meeting date in XBRL mode appeared as 19.07.2024 in lieu of 23.08.2024 though it was correctly mentioned in PDF mode.

Thereafter, the Company received an email from Query LODR (copy attached as Annexure- B) requesting us to mention the correct meeting date in the postal ballot XBRL filing i.e. instead of meeting date on 19.07.2024 it should be mentioned 23.08.2024 which was as same as mentioned in the PDF documents already filed by us with BSE. Hence on 30.08.2024 Company once again filed the voting results in XBRL mentioning the meeting date as 23.08.2024. (Copy of XBRL acknowledgement of 30.08.2024 attached as Annexure -C). Therefore, the allegation of non-submission of voting results within time permitted under Regulation 44(3) of SEBI (LODR) Regulations, 2015 is absolutely incorrect and out of place.

In view of above, you will observe that there was no non-submission/non-compliance on the part of the Company as the voting results were filed well within the permitted timeline when the e-voting ended on 23/08/2024 hence imposing of fine/penalty on the Company is baseless and irrelevant.

In view of all above facts and circumstances, we hereby request BSE to withdraw/waive the said file of Rs. 11800/- since there is no case of non-submission as the Company filed the e-voting results well within the timeline permitted under Regulation 44 (3) of SEBI (LODR) Regulations which kindly be withdrawn at the earliest and oblige.

The correspondence was received from BSE after working hours on Friday, September 13, 2024. It is to be noted that the subsequent two days were designated as non-working days. On Monday i.e. Today, this response is being filed.

The details as required under Regulation 30 of SEBI (LODR) Regulations, 2015 read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 is annexed herewith as "**Annexure - 1**".

Hence, the Company did not commit any non-compliance as alleged by BSE albeit a typo error in date of the meeting in XBRL format as stated hereinabove, However, the correct date of the meeting was mentioned in the pdf format filed simultaneously with BSE regarding same event which does not amount to non-submission of voting results as alleged by BSE.

Details of the violation(s)/ contravention(s) committed or alleged to be committed	Non-compliance of Regulation 44(3) of SEBI (LODR) Regulations, 2015 to non-submission of voting results within the period provided under Regulation 44(3) SEBI (LODR), Regulation, 2015 which is utterly incorrect and baseless as cited above and the Company has initiated due process for withdrawal of aforesaid fine imposed by BSE.

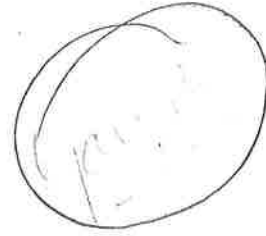
