(the Company) having its regd. office at Room No. 2, Ground Floor, 1A Mall Road, Shanti Kunj, Vasant Kunj, Delhi 110070 and CIN L17100DL1985PLC303047, would like to inform that some unknown individual/group are using the name and logo of the Company to scam/deceive the general public by creating Fake website/app or through unauthorized communication channels / links / various social media platforms etc. It appears that the scamsters are claiming to be a representative of our company and asking the public to invest on a platform (designed by using Company name and logo) and earn easy returns. It is also found that they are providing different links leading to similar page seeking personal details of the users. Further, I may clarify that the Co. has no association connection or involvement with the aforesaid platform or any such activities in any manner and it has never initiated any such scheme etc. Upon having the information about such fraudulent activity, general public/our shareholders were duly cautioned by the Company, by making a disclosure on 12/12/24 on the website of Bombay Stock Exchange where the shares of Company are listed. Such disclosure to the exchange is for the general dissemination and accessible to the public at large.
