## Sub: Outcome of Circular Resolution passed by the Nomination, Remuneration and Compensation Committee

This is to inform you that the Nomination, Remuneration and Compensation (NRC) Committee of the Board by way of Circular Resolution on 18<sup>th</sup> July, 2024 have inter alia transacted the following business:

1. Approved allotment of 77,450 Equity shares of Rs.10 each under ESOP-2007 scheme to the eligible employees of the Company on exercise of stock options vested in them.
