# After Jio, Airtel and Vi raise tariffs up to 21%

Lower than Jio's, Airtel's hike includes 2G plans but leaves out 5G

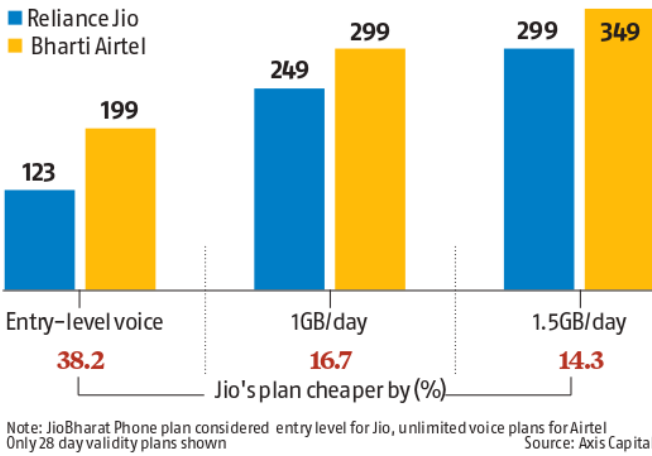
Bharti Airtel and Vodafone Idea (Vi) on Friday announced a hike in mobile tariffs by up to 21 per cent. This comes a day after market leader Reliance Jio implemented an across-the-board hike in tariffs.

While Airtel has raised tariffs by a lesser margin than Jio's 12-25 per cent, it includes Airtel's 2G subscriber base as well, a category Jio hasn't touched. Vi also focussed mostly on unlimited data plans, with validity periods from 28 days to one year. While Airtel and Jio's tariff hikes will be effective July 3, Vi will implement them from July 4, it said. Airtel has raised the cost of its voice plans by 11 per cent. This increases the price of Airtel's cheapest monthly plan, which offers 2 GB data along with unlimited voice calling, to ₹199, up from ₹179 earlier. Prices of other plans ranging from ₹455 to ₹1,799 have seen similar hikes. The same has been mirrored by Vi.

Those with data prepaid plans have seen an average 17 per cent tariff rise. The annual and data add-on categories have also seen a rise. In the data postpaid segment, generally considered a premium category, the telco has raised tariffs of its ₹399, ₹499, ₹599 and ₹999 plans by an average 15 per cent.

Vi raised the tariffs of its post-paid plans, ranging from the ₹401 plan for individual users, to the ₹1,001 family plan with a total 260 GB data cap. These will now be ₹451 and ₹1,201, respectively, increases of 12 per cent and 20 per cent. "We note that the magnitude of price increases is smaller than that announced by Jio, which effectively reduces Airtel's premium to Jio across pricing plans," UBS said in an analyst report.

The last major industry-wide tariff increase had been rolled out in December 2021, when average prices had gone up 20 per cent. Bharti Airtel had led the increase at that point. Before that, prices



had last risen mainly in 2019, when Vi was the first to trigger a rise.

Airtel said its hike was because of the need to raise the average revenue per user (Arpu) in the mobile segment beyond ₹300. A key performance metric, Airtel's ARPU is the highest among the country's top telecom players 209, beating Jio's ₹181.7 and Vodafone Idea's ₹146. However, Airtel Arpu growth had stagnated in recent quarters, rising only marginally from ₹208 in Q3. Meanwhile, Jio's Arpu stagnated at ₹181.7 for three quarters till March 2024.

In a note, Citi Research estimated Airtel's Arpu to reach ₹235, ₹270 and ₹305 over FY25, FY26 and FY27. BNP Paribas forecasts a 17 per cent revenue growth for the company in FY25. "We have ensured there is a modest price increase (less than 70 paise per day) on the

entry-level plans, in order to eliminate any burden on budget-challenged consumers," Airtel argued.

Analysts said Airtel may soon follow Jio in monetising its 5G service as well. Jio has announced that unlimited 5G will be available only to consumers on a 2GB/day or higher plan versus 1.5 GB/day earlier. It pushed consumers on its lowest priced ₹239 plan to pay ₹349 now, BNP Paribas said.

Airtel may soon do the same. "For now, Bharti has left unlimited 5G untouched; Jio has raised the minimum bar for using 5G. With 28/22 per cent of data subs on 5G, we saw the 5G monetisation coming. Bharti has maintained its commentary on the need for Arpu repair and increasing it to ₹300 in a year or so. Hence, we expect Bharti to start 5G monetisation soon," Axis Capital said.

# 68 ITC execs joined crorepati club in FY24

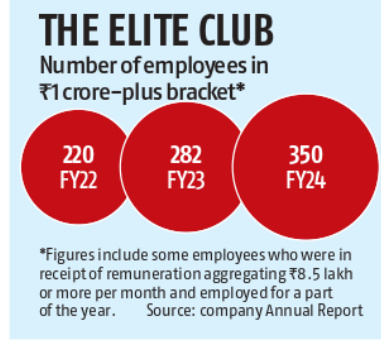

Sixty-eight executives joined the crorepati club in FY24 at the cigarettes-to-hotels conglomerate ITC. This is an increase of 24.11 per cent over the previous financial year (FY23).

According to the company's latest annual report, the number of executives drawing an annual remuneration of more than ₹1 crore was 350 in FY24.

The figure includes some employees who received remuneration aggregating ₹8.5 lakh or more per month and employed for a part of the year ended March 31, 2024. In FY23, the number of employees in the ₹1 crore-plus bracket had stood at 282. The addition in FY23 over FY22 was 62, reflecting an increase of 28 per cent. The addition in the eight-figure bracket reflects the scale of ITC's operations and spread in newer categories.

Performance against the sustainability goals of the company has also been included as a factor in assessing business performance, which, contributes to determining remuneration, the report mentioned. The chairman and other executive directors are entitled to performance bonuses for each financial year up to a maximum of 300 per cent and 200 per cent of their basic/consolidated salary, respectively, as determined by the board on the recommendation of the Nomination and Compensation Committee. ITC chairman and managing director Sanjiv Puri's gross remuneration



at ₹28.62 crore saw an increase of 50 per cent. The remuneration of key management personnel (KMP) increased 59 per cent. The company attributed it to the payment of long-term incentives during the year and also due to the increase in the number of executive directors for an interim period.

The average remuneration of employees excluding KMP increased 9 per cent. The median remuneration of employees increased by 5 per cent. The number of permanent employees at ITC as of March 31, 2024, was 24,567.

# 'AI to usher in era of technological prowess'

Anand Mahindra (pictured), chairman of IT services firm Tech Mahindra believes that the future belongs to the information technology (IT) services as it can bring synergy between IT and artificial intelligence (AI) to usher in a new era of technological prowess.

"The race does not necessarily belong to the large or the most specialised. The winners will be companies that are agile, well-prepared and can scale at speed," he said in his address to shareholders in the Annual Report. He further added, as organisations strive to stay ahead in

the digital race, IT services will play a pivotal role in enhancing that Golden Thread by integrating AI seamlessly into the core business functions. "Even without a crystal ball, I can venture to predict that Tech Mahindra, under its new leadership, is well-positioned to leap into this new orbit," said Mahindra.

Meanwhile, the company's CEO and managing director, Mohit Joshi said that Tech Mahindra is set for a "turn-around year" as it makes new invest-

ments and "optimises" costs.

The company's revenue from operations in FY24 fell 2.42 per cent to ₹51,996 crore compared to ₹53,290 crore the year before. "FY25 will be the turnaround year for us, marked by new investments in our key accounts and service lines. We will drive the integration of our portfolio companies, focus on our largest clients, and prioritise cost optimisation," said Joshi in a letter to shareholders in the firm's annual report.

Launches LLM

Tech Mahindra announced the launch of Project Indus, its indigenous foundational model designed to converse in multiple Indic languages and dialects.

The first phase of the large language model (LLM) will support Hindi language and more than 37 of its dialects.

"Project Indus is our seminal effort to develop an LLM from the ground up. Our collaboration with Dell Technologies & Intel will help deliver cutting-edge AI solutions that enable enterprises to scale at speed," said Nikhil Malhotra, Global Head, Makers Lab, Tech Mahindra.

নয়াদিগির, ২৮ জুন: মুখ ঢেকে যায় লজ্জায়। রাজধানী দিল্লিতে পঞ্চম শ্রেণির এক নাবালিকাকে গণধর্ষণের পর পাথর দিয়ে বারবার আঘাত করে নৃশংসভাবে খুন করার অভিযোগে উঠল প্রতিবেশী যুবক ও তার সঙ্গীর বিরুদ্ধে। ঘটনটি ঘটেছে দিল্লির নরেন্দ্রা এলাকায়। মেয়েটির বাবার অভিযোগের ভিত্তিতে তদন্তে নামে ২ অভিযুক্তকে গ্রেপ্তার করেছে দিল্লি পুলিশ। দুই অভিযুক্তকে হোপাজতে নিয়ে জিজ্ঞাসাবাদ শুরু করেছে পুলিশ।

যুবককে হোপাজতে নিয়ে পুলিশ জানতে পারে, ওই নাবালিকাকে অপহরণ করে এক বন্ধুর সঙ্গে মিলে গণধর্ষণ করে। সেই সূত্রেই দেহদণ্ড নামে এক তিরিশ বছরের যুবককে গ্রেপ্তার করে দিল্লি পুলিশ। পুলিশের দাবি, জেরায় অপরাধীরা স্বীকার করেছে ঘটনার দিন রাতে ওই নাবালিকাকে মোমো খাওয়ানোর ঘোষ দেখিয়ে নিয়ে গিয়ে দেহদণ্ড নামে বন্ধুটির সঙ্গে মিলে গণধর্ষণ করে। মেয়েটির অবস্থা শোচনীয় হওয়ায় ধরা পড়ে যাওয়ার আগে দু'জনে তাকে খুনের সিদ্ধান্ত নেয়। নৃশংস ভাবে পাথর দিয়ে খেঁচলে মেয়েটিকে হত্যা করে বাড়ির কাছেই হেহ ফেলে চম্পট দেয় বৃদ্ধতারা। পুলিশের তরফে জানানো হয়েছে, দেহ উদ্ধার করে ময়নাতদন্তের জন্য পাঠানো হয়েছে। রাহুল ও দেহদণ্ড নামে ২ অভিযুক্তের বিরুদ্ধে গণধর্ষণ, খুন-সহ পকসো আইনে একাধিক ধারায় মামলা দায়ের করা হয়েছে।
